**ROAD: L-7112 - RATHOE, CO. CARLOW**

Carlow County Council wishes to give notice of its intention to temporarily close the above road between Rathoe Road and Ardbearn Cross to facilitate Kendra Civil Engineering Ireland Ltd in carrying out essential maintenance works for the grid connection from the Garreenleen Solar Farm Substation to the ESB substation at Kellis.

- Parameters:**
- Local road speed = 80km/h
  - Distance between Advance signs = 200m
  - No. of Advance signs = 4
  - Min. Visibility of signs = 120m
  - Longitudinal Safety Zone = 80m
  - Lateral Safety Zone = 1,2m
  - Lead In Taper = 45 degree
  - Max. at Taper cone spacing = 3m
  - Max longitudinal cone spacing = 12m.
  - Traffic Flow Is Road Closure with Diversion

- Notes:**
- All signs to comply with Chapter 8
  - Exact sign positions to be agreed on site.
  - Safety zones to be maintained at all times.
  - Signs to be positioned so as not to obstruct other road users.
  - Min. Line width to be maintained at 3m at all times, 3,25m where possible.
  - End of Road Works signs to be placed within 20m of works area end.
  - Existing Signage to be covered whilst TM in operation.
  - Marshal at both end of Road Closure.
