he County of Carlow (Contae Cheatharlach) is located inland within the South East of Ireland in the province of Leinster covering an area of 896 square kilometers. The County is strategically located and has excellent access to transport infrastructure through its location on the M9 Dublin Waterford motorway, the Dublin Waterford main rail line and the N80 national road linking Rosslare Europort to the Midlands.

The population of County Carlow recorded in the 2022 census was 61,931. The county town of Carlow is located in the northwest of the County along the border with County Laois. The Council is made up of 18 elected members within 3 municipal districts (Carlow, Tullow and Muinebheag). With the Cathaoirleach elected by the members annually.

Along with the Corporate Policy Group, 4 Strategic Policy Committees develop and recommend policy to the Council. Committees are made up of elected members and representatives designated external sectoral interests.



Sustainable Development Goals (SDGs)

he UN Sustainable Development Goals (SDGs) are a set of 17 global goals adopted by all United Nations Member States in 2015 as part of the 2030 Agenda for Sustainable Development. They aim to end poverty, protect the planet, and ensure prosperity for all by 2030.

Ireland's Second National Implementation Plan for the Sustainable Development Goals 2022-2024, builds on the role of local government in Ireland and incorporates specific actions to do so which include:

- i. Showcasing, sharing, and building on existing initiatives
- ii. Capacity building and awareness raising
- iii. Embedding the SDGs in Governance and reporting frameworks
- iv. Incorporating the SDGs within local planning frameworks
- v. Community Engagement

Furthermore, local authorities are recognised as one of Agenda 2030's nine "Major Groups", which play a crucial role in sustainable development and Agenda 2030 also highlights the role of local authorities and communities in sustainable urban development.

Carlow County Council were appointed as one of the first Local Authority SDG Champions in 2019 and currently holds the role of SDG Ambassador.

The role of SDG Ambassador includes:

- → Advocate and promoter of the SDGs and sustainable development
- → Acts as a good practice example of how an organisation or group can contribute to the SDGs and integrate the SDGs into their work or activities.
- → Shares learnings with others.

Pádraig O Gorman, Director of Servies currently holds a position on the National SDG Localisation Working Group.

The objective of this group is to develop and oversee SDG localisation in Ireland, building on the work already underway at local level, and as set out in the SDG National Implementation Plan.

Carlow County Council continues to work to advance the SDGs, including through:

- → the incorporation of the SDGs into our policy documents,
- → joining/establishing local and/or international partnerships,
- → the holding of information events with external groups including Universities, PPNs, Tidy Towns and Creative Ireland.

The 2025 Annual Report presents a breakdown of the SDG Goals and Targets supported by each Department.

Moldovan Presidential Election



Carlow County Council were delighted to receive a request from the Moldovan Ambassador to Ireland, Larisa Miculet, to be one of limited number of centres throughout the country to host a count centre for the Moldovan Presidential Elections and Republican Constitutional Referendum on EU Membership in Autumn 2024.

Register of Electors

The Council is responsible for the compilation of the Register of Electors for the County of Carlow. Under the new Electoral Reform Act 2022, a national program 'Modernisation of the Electoral Register' was carried out to reform the electoral registration process. It provides for rolling, or continuous registration, which will standardise and simplify the process.

To support greater participation, several additional features were also provided for, including the facilitation of anonymous registration for persons whose safety may be at risk if their names are published in the register; provisions to enable preregistration for 16 and 17 year olds; arrangements for those with no fixed address; and bringing better and more flexible options for people who because of mental health difficulties are not able to attend polling stations to vote.

In 2024, several electoral events led to a surge in applications for inclusion on the Carlow voter register. This increased the number of voters in Carlow by 7.33%. The overall count of registered voters in 2024 reached 49,621, comprising 18,899 in the Carlow Local Electorate area, 14,321 in Muinebheag, and 16,401 in the Tullow area.

Corporate Property

The Corporate Affairs Section is responsible for all Corporate Property (Except Social Housing and Roads) and the maintenance and upkeep of same. Property related supports and services were provided including, conveyancing of sales, purchases and leases of property to and from other parties, Section 183's, land-related queries, insurance, and facility management.

Business in the Community Ireland (BITCI)

Carlow County Council are working jointly with Business in the Community Ireland and Tyndall College, Carlow for the delivery of the Towards Your Future Programme.

This nationwide programme provides students with an opportunity to meet officials from the Local Authority in order to learn about and prepare for the workplace. The Programme consists of a number of steps including Meet & Greet, Programme Overview; Day in the Life, sharing team roles & daily duties; Local Authority Site Visit/s; Interview Preparation and review.

To complete the Day In The Life Session/s which are an integral element of the Programme, Students & Teachers attended site visit/s to the Fire Station, Carlow and the Council Chamber, County Buildings where presentations were provided from service areas including Climate Change; The Library; Sports Partnership & Corporate Governance.

Data Protection

Carlow County Council processes all personal information in accordance with the General Data Protection Regulation 2016 (GDPR) and the Data Protection Acts, 1988 to 2018. The GDPR sets out more extensive obligations on data controllers and processors and provides strengthened protections and rights for data subjects. The Data Protection Officer (DPO) received public sector-specific training in 2024 and has continued to actively engage with sections in carrying out Data Privacy Impact Assessments and executing Data Processing Agreements.

Records Management & Archives

Corporate Services is responsible for the implementation of the National Retention Policy for Local Authority Records. 450 boxes of non-current records were transferred to the Records Centre in 2024. New procedures for on-site destruction of records were implemented. The Archivist participated in Heritage Week, and worked with the Department of Children, Equality, Disability, Integration and Youth on the Mother and Baby Institution Payment Scheme.

Carlow County Council has 18 Elected Members which represent 3 municipal districts of Carlow, Tullow and Muinebheag. Corporate Affairs manages CCC Council Meetings, Carlow Municipal District Meetings, Corporate Policy Group meetings and Deputation.

Health And Safety

n 2024, Carlow County Council continued to implement its Occupational Health and Safety Management System and seek continuous improvement in Health and Safety.

A continued focus has resulted in substantial implementation of the health and safety document control app in the Roads & Transportation Department for the management of health and safety documents and forms such as SSWP's, Traffic management plans, plant, vehicle and equipment checks. It is an objective to extend use of the app in other departments. Additionally, the app is used to conduct safety inspections as per the ongoing safety inspection schedule. **45** no. health & safety workplace inspections were carried out

in 2024. Tablets are being used to deliver and record compliance with health and safety requirements with a facility to report incidents electronically. There was a total of 10 workplace incidents which includes 1 no. IR1 reportable accident and 2 no. IR3 dangerous occurrences. Consultation and communication with staff during the year and ongoing proactive checking ensures safety, health and welfare best practice is adhered to. In the latter part of 2024, a new assistant health & safety officer joined the health and safety unit.

he overall objective of the Planning Department is to promote the development of the County in a manner which facilitates sustainable economic and social progress. The day-to-day operation of the department covers a number of functional areas namely development management, planning enforcement, compliance, taking in charge of residential developments, derelict sites, dangerous structures and forward planning.

DEVELOPMENT MANAGEMENT Planning Applications

FORWARD PLANNING

Carlow County Development Plan 2022-2028 - Two Year Progress Report

In accordance with Section 15(2) of the Planning and Development Act 2000 (as amended) the Chief Executives report on the progress achieved in securing the objectives of the Carlow County Development Plan 2022-2028 was presented to the Elected Members of Carlow County Council at a Special Council meeting on the 30th July 2024. A copy of the report can be accessed here <u>Carlow County Development Plan</u> 2022-2028 | Carlow County Council's Online Consultation Portal.

Carlow-Graiguecullen Joint Urban Local Area Plan 2024-2030

Carlow County Council, in conjunction with Laois County Council completed the review of the Carlow-Graiguecullen Joint Urban Area Plan. The Draft Carlow-Graiguecullen Joint Urban Local Area Plan was finalised in Q4 of 2023, was subject to public consultation

and material alterations in 2024 prior to its formal adoption by Carlow County Council on the 30th July and Laois County Council on 29th July 2024. The Carlow-Graiguecullen Joint Urban Local Area Plan 2024-2030 provides the spatial planning framework including land use zoning for the future development of the Carlow-Graiguecullen Urban Area.

Tullow and Muine Bheag/Royal Oak Local Area Plans

The review of the Muine Bheag – Royal Oak Local Area Plan 2017-2023 (as extended) and the Tullow Local Area Plan 2017-2023 (as extended) has commenced.

The Muine Bheag-Royal Oak Local Area Plan 2024-2030 - Issues Paper was put on public display for a 4-week period. A Chief Executive's Report was prepared and presented to the Elected Members on the 4th April 2024. The drafting of the LAP has commenced with the Draft LAP document expected to be put on public display in Q2 of 2025.

The Issues Paper for the Tullow Local Area Plan 2024-2030 was also published in March 2024. As part of this consultation process, an information session was held for members of the public on the 27th March, in the Tullow Library. Following this consultation period, a Chief Executive's Report was prepared and presented to the Elected Members on the 15th May 2024. It is anticipated that the Draft LAP which will be published circa Q3 of 2025.

Residential Zoned Land Tax (RZLT)

Action 15.2 of Housing for All specifically identified the introduction of a new tax to activate vacant land for residential purposes, this tax is known as the Residential Zoned Land Tax and replaced the vacant site levy. The principal purpose of the residential zoned land tax is to encourage the timely activation of zoned and serviced residential development land for housing. The proposed measure is to activate existing planning permissions and zonings where housing is permitted and where the land is connected to, or has access to services, but remains undeveloped. The Annual Draft RZLT Map

(2025 Liability Year) was published on 30th January 2024 and subject to public consultation. The submissions received with respect to the inclusion or exclusion of land in the RZLT were assessed and determination reports were completed as appropriate. In addition, all the land rezoning submissions/ requests received by the Planning Authority during the RZLT public consultation periods in 2023 and 2024 were assessed and a Chief Executive's Report on these rezoning requests was completed in July 2024. A variation to the Carlow County Development Plan 2022-2028 is being progressed regarding rezoning submissions in 2024 and due for completion in Q1 of 2025.

The Annual Draft Map for 2026 was prepared for the purposes of identifying land that satisfies the relevant criteria and is to be subject to the residential zoned land tax with submissions being sought up to 1st April 2025.

The first liability date for the tax is the 1st February 2025 and will be administered by the Revenue Commissioners.

The Planning Department in accordance with the Planning and Development Act 2000 (as amended) seeks to ensure that planning permissions are complied with.

Written complaints of unauthorised development, where they appear to be well founded, are investigated. Following an investigation of a bone fide complaint, the commencement of the enforcement steps

is initiated by the issue of a Warning Letter followed by the issue of an Enforcement Notice should the matter not be satisfactorily resolved following the issue of a Warning Letter.

In the event of non-compliance with the Enforcement Notice legal proceedings are initiated.

A total of 73 complaints were received during 2024.

Taking of Estates In Charge

Taking of Estates in Charge Under the Planning and Development Act 2000 (as amended) requests to take estates in charge can be made by the Developer or the majority of the owners residing in the development. The Planning and Development Act 2010 allows the Local Authority to take part of an estate in charge.

In 2024, significant progress was made on the taking in charge of housing estates. 6 estates were taken in charge, and the intention of the Council to take an additional 3 estates in charge was advertised before year end. Additionally, 5 new requests for TIC were received in 2024. The Council remains actively engaged with Uisce Éireann

to address water and wastewater issues in unfinished estates throughout the County.

Dangerous Structures

The Planning Department implements the Local Government (Sanitary Services) Act 1964 in relation to Dangerous Structures & Places. The department co-ordinates with all necessary stakeholders and expertise to minimise any potential risk. A total of 4 complaints were received in 2024.

TOWN CENTRE FIRST

"The Town Centre First policy aims to create town centres that function as viable, vibrant and attractive locations for people to live, work and visit, while also functioning as the service, social, cultural and recreational hub for the local community".

Muine Bheag Town Centre First Plan

Carlow County Council, with support from the DRCD Suite of Supports 2024 – Measure 3 and the "Our Rural Future" Programme, has begun developing a Town Centre First Plan for Muine Bheag. A Town Team, made up of 12 community members representing various stakeholders, has been formed to guide the process. To engage and collaborate with the Muine Bheag community, a series of activities have been held, including a public information session, a workshop, and surveys, to gather input for the plan's development. A SWOT analysis was conducted on the town, and the plan's themes will be based on the findings of this analysis. The Muine Bheag Town Team is also collaborating with the South East Technical University (SETU), where a group of international students, as part of their curriculum, is conducting a Health Check on the town.





Graiguecullen Town Park

Town & Village Renewal Scheme (TVRS)

The TVRS is designed to support the revitalisation of rural Ireland through a renewed focus on town centre economic and social recovery and regeneration. This will be achieved through projects focusing on town centre regeneration, enhancing our Streetscapes and bringing vacant and derelict buildings back into use as community multipurpose spaces through refurbishment and renovation. 4 applications were approved in 2024 for the following locations and amounts and works have commenced and are ongoing

Rural Regeneration Development Fund (RRDF)


In May 2024, RRDF Call 5 Category 1 funding was approved for the redevelopment of a former school building in the heart of Rathvilly into a multi-purpose community hub. This project will revitalise the town centre, provide essential community facilities, and help foster a renewed sense of community. The estimated cost of the project is €2.7 million.

DRCD Suite of Supports 2024 – Measure 3

A project involving the enhancement of the 1798 Park in Tullow, including the creation of a new accessible play area received funding of €45,718.00 under this Suite of Supports to support the pre-development activities and to bring the project to the planning stage. The project will include environmental works to manage overgrown riverbank vegetation, as well as upgrades to planting, paving, play equipment, and seating throughout the park. Additionally, the project will regularise and increase the number of parking spaces. The estimated cost of the project is €285,000, and it is part of the Tullow Town Centre First Plan.

Urban Regeneration Development Fund - Call 3

Carlow County Council have been approved for a programme of 14 properties under the above funding stream to the value of €1.5m. This funding support acts as a dedicated revolving fund designed to address the financial barrier and risk faced by Carlow County Council in seeking to address long term vacant and

derelict properties across Carlow Town. This funding is being made available to acquire long term vacant or derelict properties for onward sale or re-use. The Revolving URDF Fund will be replenished from the proceeds received from the sale or reuse of properties and sites, allowing a local authority to establish a rolling programme of acquisitions to tackle long term vacancy and dereliction.

The Regeneration team have activated all 14 properties and engaged with the owners to assist them in bringing the property back in to use themselves, or where necessary, such as where a property is unregistered or engagement with the owner is not possible, to acquire the property compulsorily.

These properties are not being targeted with a view to retaining them as Local Authority stock for use as Social Housing, they are solely being targeted for onward sale.

In addition to the properties within the URDF area, a pilot scheme was undertaken within the Local Authority to identify properties outside the URDF area that could be placed on the open market for sale. To date one property was identified, CPO'd and has gone sale agreed.

CPO Activation Programme

In the face of significant housing demand, it is crucial that existing houses and properties are fully utilised. Although the reasons for vacancies can be complex, the regeneration and reuse of vacant properties in our towns, villages, and rural areas can provide much-needed housing while revitalising these areas and benefiting the communities that live there.

The CPO Activation Programme was launched in April 2023, with Carlow County Council playing a central role in activating and bringing properties back into use. This is achieved through engagement with property owners and the implementation of various available schemes and measures. Compulsory acquisition is one of the tools Carlow County Council may use, particularly when other efforts to engage owners of vacant and derelict properties have been unsuccessful.

Croí Cónaithe (Towns) Fund

The Croí Cónaithe (Towns) fund is a key initiative which underpins the policy and objectives set out in Pathway 4 of Housing for All programme.

Vacant Property Refurbishment Grant

This Scheme was launched in July 2022. This is one of the measures which has been implemented to address vacancy and bring properties back into use. It benefits those who wish to turn a formerly vacant house or building (as per scheme outlined) into their principle private residence or to make it available for rent. A maximum grant of up to €50,000 is available for the refurbishment of vacant properties. There is also a further maximum top-up grant amount of up to €20,000 available where the property is confirmed by the applicant to be structurally unsound and dangerous, or, if the property is already on the local authority's Derelict Sites Register. Once an applicant receives approval in principle for the grant, they can then proceed to complete their project. On completion of all works, the grant is then drawn down and paid directly to the applicant.

Ireland South East

Carlow County Council provided funding to the Ireland South East Office for the coordination of a variety of actions in the area of economic development and business support.

Carlow Tourism

Carlow County Council supported the Annual Plan for Carlow Tourism under their MOU with Carlow Tourism and strategic framework for the future support of the Tourism Sector in County Carlow.

Streetfest

Streetfest was a series of entertainment events and artisan craft staffs held on Lower Tullow Street over 6 weekends from April to June. It served as a pilot project for the potential pedestrianisation of Lower Tullow Street, aiming to enhance the shopping experience and create an unforgettable atmosphere.

Economic Marketing

Carlow County Council commissioned a variety of publications in association with the Sunday Business Post, KCLR and the Nationalist during 2024 promoted Carlow on a regional and national level.

Communications & Engagement Group

Carlow County Council facilitates a Communications & Engagement group of business sector agencies and support bodies to ensure a coordinated approach to business community engagement. The group hosted the annual Carlow Business Day in October 2024 which was attended by over 200 people.

Opportunity 2024

Carlow County Council published 'Opportunity 2024', a ground-breaking commuter study, designed to highlight the skills and experiences of Carlow's workforce and identify opportunities for growth.

Enterprise Space Development

The Council worked with Carlow Community Enterprise Centres CLG to develop a series of projects to provide Enterprise Space in the County. These projects are supported by Enterprise Ireland & Town & Village Renewal Scheme. Construction neared completion on the Station House – Community & Enterprise Hub in Hacketstown with pre-development carried out in respect of the Catalyst Project in Carlow Town and Presentation House in Bagenalstown.

Development & EU Funding

Carlow County Council was a partner in the successful application for a new EU project, European Emerging Craft Platform – Craftwork 4.0 All, an ambitious initiative funded by the Creative Europe Programme under the Call for European Platforms for the Promotion of Emerging Artists. This programme will launch in 2025 InnoCom, a project in respect of business engagement funded under Interreg Europe,

InnoCom, a project in respect of business engagement funded under Interreg Europe, continued. Carlow County Council hosted an international meeting of project partners and stakeholders in September 2024.

Christmas 2024 Programme

Spotlight on Biodiversity

The Carlow Biodiversity Officer was appointed on January 6th 2024, and successfully secured €101,689 grant funding under the Local Biodiversity Action Fund (NPWS), and €20,000 grant funding under the Local Biodiversity Action Plan Fund (Heritage Council), to progress implementation of Actions under the Carlow Biodiversity Action Plan 2023-2025.

These included:

- → Carlow Wetlands Survey to establish the extent of wetland habitat in Carlow.
- → Carlow Hare's Corner Project to facilitate landowners to create a space for nature through installing a wildlife pond, or planting a heritage orchard or miniwoodland.
- → Carlow Invasive Species Control to restore riparian habitat through the control of rhododendron and cherry laurel.
- → Carlow Catchments Hedgerow Survey to assess hedgerows with a water quality function, i.e. parallel to rivers, and the bottom of sloping land, and with a good base structure.
- → Carlow Otter Survey to map the extent of their distribution on the River Burrin, River Mountain, and urban sections of the River Barrow.
- → River Burrin Riparian Habitat Gaps & Fragmentation Survey to map priority areas along the river for restoration intervention.
- → Orchard River & Riparian Restoration restoration works to reinstate spawning gravels and strengthen the riparian zone.
- → Carlow Protected and Rare Flora Survey

 to assess the current status of rare flora records.
- → Carlow Mayfly Recording Project (part of application with 27 other Local Authorities and LAWPRO)
- → Carlow Hedgehog Survey a citizen science survey to establish extent of the Carlow population.
- → Carlow Significant Tree Survey to update a 2004 survey of over 600 significant trees.

Applied Learning Programme for High Nature Value Landscape Communities

The aim of this project was to deliver an improved understanding of results-based landscape management to the broader Blackstairs community, encouraging farming and non-farming relationships, and strengthening the foundations for future community stewardship.

The delivery of the project revolved around five main elements:

- 1 Targeting non-farming landowners in the Blackstairs area to prepare "Plans for Nature" (part of the Hare's Corner initiative to create space for nature) – 13 Plans completed
- 2 Delivering an in-person Heritage Keepers workshop to local community and interest groups, with funding provided for six local action projects, including an archaeology assessment of the Nine Stones, and a display set of wildlife infrastructure (i.e. bird and animal boxes).

Spotlight on Waste Management Environmental Inspection Plan Outcome 2022

The Department of the Environment, Climate and Communications set the National Enforcement Priorities (NEPs) annually. Each local authority must submit to the Environmental Protection Authority it's inspection plan to respond to the NEP's and a detailed return for inspections and outcomes for the preceding year (called the RMCEI Plan).

The EPA concluded the evaluation of all Local Authority performances concerning National Enforcement are Priorities for 2023. Carlow County Council delighted not only to have met the stipulated standard but also attained a commendable 85%, surpassing the national average of 70%.

Litter Management Plan 2024-2026

In accordance with Sections 10 – 13 of the Litter Pollution Act 1997, as amended, Carlow County Council reviewed its Litter Management Plan 2021-2023, and prepared a Litter Management Plan for 2024-2026.

The Local Authority Litter Management Plan aims to tackle litter-related issues in County Carlow through a structured and strategic approach.

The plan outlines the current state of litter across the county, relevant legislation on litter control, services offered by Carlow County Council, as well as initiatives focused on education, awareness, and engagement with the community and businesses.



Environmental Awareness Rubbish Film Festival.

The project was funded through Carlow's allocation under the National Anti-Litter & Anti-Graffiti Scheme. It included environmental presentations, litter picks, and workshops delivered by the Environment Team and local Tidy Towns representatives in six secondary schools. Following this, Create School provided workshops and support in key Next Generation Skills, empowering students to produce short films that highlight global and local issues related to waste, pollution, and their impact on both the county and the planet.

Congratulations to Presentation College, Carlow, who were Runners-Up for "Best Film" at the National Finals with *Out of Sight, Out of Mind,* Coláiste Aindriú, Bagenalstown, who were regional Runners-Up with their film *Something Fishy*, Borris Vocational School, who were regional Winners for Best Poster with *Don't Ruin It*.

Working with our Schools

Schools programme. 9 Schools were awarded flags in 2024.

Voice Ireland Picker Palls campaign has been engaged to work with 14 primary Schools

across the County to facilitate increased litter awareness and engage in litter prevention activities.

Spotlight on Climate Action


Adopted by the Elected Members in January 2024, Carlow Local Authority's Climate Action Plan 2024-2029 is a comprehensive framework aimed at achieving the targets set out in the Climate Action and Low Carbon Development (Amendment) Act 2021. The suite of 73 actions contained in the plan provides a structured pathway to reduce emissions, enhance climate resilience, and support a just transition for the wider Carlow community.

As at 31st December 2024

- 36 actions have been completed.
- 20 are in progress.
- 17 have not started.

CO2 and Energy: Monitoring & Reporting 2024.

Annual Monitoring and Reporting (M&R) report is mandated under the Sustainable Energy Authority of Ireland (SEAI) regulations, which require public sector bodies to report their energy performance directly to SEAI – in accordance with SI 426 of 2014.




The M&R report focuses on the following key points: analysis of energy consumption and Gren House Gas emissions; comparison with efficiency and emissions targets for 2030; data presented by Carlow Local Authority; tracking progress towards 2030 targets; focus on achieving energy efficiency goals; improvements and innovation.


Annual reporting is released with a oneyear delay is prepared in conjunction with our energy partners, Southeast Energy Agency and the M&R reporting 2023 data is now available on the Sustainable Energy Authority of Ireland (SEAI) website. In 2023 Carlow Local Authorities produced 1,785,037 Kgs CO2 which is an overall reduction of 1,023,632 Kgs CO2 from the baseline figure of 2,808,669 Kgs CO2.

As the 2030 target is set at 832,670 Kgs CO2 the Local Authority must achieve a further reduction of 952,367 Kgs CO2 before 2030.

- → Thermal: Emissions have been decreasing since 2019 but remain significantly above the 2030 target, indicating a need for more aggressive reduction strategies.
- → Transport: Emissions have fluctuated with only a slight decrease from the baseline. Carlow Local Authority have made significant progress in this area in 2024.

Carlow Climate Action Week 2024.

The inaugural Carlow Climate Action Week took place from the 14th to 20th October 2024. In total, 35 events took place throughout the week. 21 of these free events were organised/led inter-departmentally in partnership with the Climate Team.

9 Community based events were hosted by recipients of the Community Climate Action Fund, and 5 events were hosted in partnership with stakeholders including, Teagasc, SETU, Carlow College, South-East Energy Agency, Sustainable Energy Authority of Ireland (SEAI) and Carlow PPN. There was an overall attendance of circa 1,300 across the 35 events, which took place both in person and online.

Climate Literacy Training

A six-week training course for individuals over the age of 60 began on November 6th at An Gairdín Beo. The program aimed to enhance participants' climate action education, helping them understand how their daily activities contribute to carbon emissions and, in turn, climate change. It also guided them in creating a plan to reduce their personal carbon footprint. A total of 24 people took part in the course.

Schools in Carlow Town engaged in a climate literacy programme delivered by Education for sustainability. During the 10-week course participants addressed the gap between knowledge and action by providing teachers, principals, and students with an action-led roadmap of knowledge, tools and skills designed to enable them to live more sustainably by improving climate literacy.

UN Sustainable Development Goals.

As former SDG Champions, Carlow County Council currently hold the role of SDG Ambassadors.

During SDG week 2024 the Environmental Awareness Officer at Carlow Local Authorities designed and delivered a webinar entitled "the Health and Wellbeing Benefits of Growing and Sourcing Local Food" directly linking the following SDGs to local food production.

ounty County Council maintains Fire Brigades in four Fire Stations located in Carlow Town, Muine Bheag, Tullow and Hacketstown. A Fire Service Training & Development Centre utilised by Fire Services from across Ireland, The National Directorate for Fire & Emergency Management, The Irish Defence Forces and The Irish Air Corps is also based in Hacketstown Fire Station.

The dedicated crews, together with modern vehicles and equipment, ensure delivery of a prompt, efficient and effective service responding to a total of 535 separate emergency incidents resulting in 696 mobilisations by County Carlow Fire Brigades in 2024. This represented a welcome 6% reduction in attendances at emergency incidents when compared to the total figure for 2023. There were no fire fatalities recorded in Co. Carlow in 2024. The operational response is supported by the Eastern Regional Control Centre located in Dublin Fire Brigade HQ in Townsend St, which receives calls from the public through the 999/112 service and mobilises the appropriate fire service resources in County Carlow. Services such as administration, fire prevention activities, Building Control, Major Emergency Management etc. are delivered from the Fire Service Headquarters at Green Lane, Carlow Town.

Key Performance Indicators

The Local Authority Performance Indicator Report 2023 carried out by NOAC (National Oversight and Audit Commission) which was published in September 2024 highlighted that Carlow Fire Authority had a cost per capita of €46.71 per head of population. This is in line with the national average of €45.96 per capita for the operation of Retained Fire Stations. The NOAC report also highlighted that in 87% of mobilisations, a crew from Carlow County Fire & Rescue Service arrived at the scene of an emergency incident within 20 minutes from time of mobilisation.

Emergency Services & Building Control

The Code of Practice for Inspecting and Certifying Buildings and Works in relation to inspections of new buildings, for which valid commencement notices have been received, sets a minimum requirement of 12 – 15%. County Carlow Building Control Authority achieved an inspection rate of 22%. Applications for Fire Safety Certificates were granted within the statutory period of 2 months in 74% of cases, above the national average of 52%.

Safety, Health & Welfare & Quality Management Systems

In December 2023, Carlow County Fire & Rescue Service's Safety Management System was certified to ISO 45001 by the National Standards Authority of Ireland. This is confirmation of the safety management system in Carlow County Fire & Rescue Service complying with international best practice and recognition of the work and dedication across all sections and levels of the service required to achieve this standard. The awarding of ISO 45001 means that the organisation is internationally recognised in an elite category of businesses, one of a small number of fire services that have attained this standard in Ireland. In 2024 the County

Fire Service maintained its commitment to this standard and underwent an internal audit in preparation for the 2-day reaccreditation audit by the National Standards Authority of Ireland in Q1 of 2025.



Carlow County Fire & Rescue Service also applied for registration to the ISO 9001 Quality Management System standard which sets out the essential requirements for a practical and effective quality management system (QMS) which is, in essence, a system for minimising risk and maximising opportunity. The standard is the first port of call for almost all organisations, large or small, public or private, that have decided to strengthen, streamline or review their management procedures. It can be used

to focus on improving performance in a particular department, plant or site. This would be confirmation of the Quality Management System in Carlow County Fire & Rescue Service complying with international best practice and recognition of the work and dedication across all sections and levels of the service required to achieve this standard. To achieve this award, the County Fire Service underwent an internal audit in 2024 in preparation for the 2-day registration audit by the National Standards Authority of Ireland in Q1 of 2025. Should the County Fire Service be successful in attaining this accreditation they will be one of very few nationally with both ISO 45001 & ISO 9001 standards.

Capital Funding

The Minister for Housing, Local Government and Heritage, Darragh O'Brien TD, announced funding of €20.8 million for the provision of 40 new 'Class B' fire appliances, which will be allocated across the country's 27 Local Authority Fire and Rescue Services. Carlow County Fire Service received an allocation of 1 new Class B Appliance as part of this announcement which is scheduled for delivery in Q1 2026. Carlow County Fire & Rescue Service received final approval to proceed to tender for design and engineering services for the refurbishment and upgrade of Muine Bheag Fire Station which will greatly enhance the working conditions for firefighters within the station. Carlow County Fire Service received funding from the National Directorate for a number of Capital Projects during 2024 including:

Extensive capital works were completed in the Hacketstown Training & Development Centre during 2024. Works included replacement of live fire training units in the Breathing Apparatus and Compartment Fire Behaviour facilities and the installation of a Breathing Apparatus and PPE decontamination machine.

Other works included construction of a forklift truck storage building, improved changing areas for students and instructors' and improved classroom facilities. Approval in principle has been received for funding for additional improvement works to the centre involving construction of specialist working at heights training tower, a new laundry building for PPE, vehicle storage buildings and replacing some changing facilities.

Training

A A range of specialist Training Courses were delivered to operational firefighters during 2024. Officer Training as well as training in the operation of Pumps, Compressed Air Foam, Breathing Apparatus, Compartment Fire Behaviour, Working at Heights, Winches, Abrasive Wheels, Emergency Service Vehicle Driving, Emergency First Responder and Cardiac First Responder was delivered to all crews. The County Fire Service also invested in new Mental Health First Aid and Suicide intervention training for staff. The number of Critical Incident Stress Management Station Peer Supporters was increased to two in each station with training provided

for the new Peer Supporters in 2024. New Manual Handling, Breathing Apparatus, Compartment Fire Behaviour and Road Traffic Collision Instructors were trained in 2024 further developing the skill set and resilience within the County Fire Service. Recruit Firefighters completed initial basic recruit training as well as training in the use of Breathing Apparatus and Compartment Fire Behaviour. Carlow Firefighters completed the annual training programme in a range of training disciplines during 2024.





Operations

Crews from across County Carlow attended a to a total of 535 separate emergency incidents resulting in 696 mobilisations by Carlow Fire Brigades in 2024. This represented a welcome 6% reduction in attendances at emergency incidents when compared to the total figure for 2023.

There was no fire fatalities recorded in Co. Carlow in 2024. A slight 4% increase was observed in attendances at Road Traffic Collisions in 2024 compared to 2023. Accidental activations of monitored fire alarms in commercial and domestic premises continue to create issues for the fire service, however a welcomed 8% reduction was observed in 2024 compared to 2023. The County Fire Service continues to develop initiatives to try to reduce them.

Three new recruit firefighters commenced operational duty with Tullow Fire Brigade including the first female firefighter to join this Brigade. Hacketstown Fire Brigade also saw three new firefighters join their ranks. Carlow County Fire & Rescue Service became the first Fire Authority in Ireland to achieve the full complement of 12 firefighters in all stations as per the recent WRC agreement. All promotional positions were also filled in 2024. There are currently 49 operational firefighters including Driver/Mechanics, Sub Officers and Station Officers, and 3 Senior Fire Officers employed in Carlow County Fire & Rescue Service.

Community Fire Safety & Fire Prevention

In addition to its operational activities, Carlow County Fire & Rescue Service was also very active in promoting fire safety and continues to inspect public-assembly buildings in an effort to meet the obligations under the Fire Services Act 1981 & 2003. Carlow County Fire & Rescue Service has taken a more proactive role in promoting Community Fire Safety in particular during Fire Safety Week and Positive Ageing Week which took place on September 30th to October 6th 2024, members of the public were invited into Stations to view our equipment and appliances, speak to Fire Prevention Officers and view fire safety demonstrations and displays. Daily Fire Safety messages were published on social media pages as well as radio interviews undertaken with KCLR and Beat FM. Carlow County Fire Service continued to deliver the Home Fire Safety Check initiative during 2024. Firefighters visit older persons in their homes, carry out a home fire safety check, provide advice to the homeowner in relation to fire safety and install smoke detectors where required. Over 150 Home Fire Safety Checks were completed by County Firefighters in 2024.







The annual licensing and inspection of premises was completed in September with publicans, dance and restaurant license renewal applications before the Courts. In total 46 premises were inspected in the run up to the Court date in late September. A large body of work was undertaken to comply with the provisions of the Fire Services Act along with the administrative duties associated with issuing certificates, letters and conditions of license. A number of enforcements were carried out on public premises as well as warning letters issued to premises owners and occupiers following inspections on foot of complaints by members of the public and issues that were highlighted post incident that may have been brought to the Fire Officers attention.

Building Control

The Building Control section actively manages the Building Control Management System and carries out routine inspections of construction projects to ensure compliance with all parts A to M of the Building Regulations during construction stage, validating and technically examining Disability Access Certificates as well as advising members of the public on the system. All Fire Safety Certificate and **Disability Access Certificate Applications** are now being made through the Building Control Management System. The Building Control Section worked closely with the National Market Surveillance Office which monitors the quality and standard of construction products offered for sale within County Carlow. A number of inspections of premises who offer construction products for sale within County Carlow received unannounced initial and follow up inspections.

Hacketstown Training & Development Centre

Hacketstown Training & Development Centre is regarded as the leading facility and a critical piece of strategic infrastructure in Ireland for the delivery of firefighting training for operational firefighters and fire officers. The facility provides Recruit Firefighter Training, Breathing Apparatus Training, Compartment Fire Behaviour Training, Road Traffic Collision Training, Medical Training and Working at Heights Training. A National Directorate for Fire & **Emergency Compartment Fire Behaviour** Instructor Training Course was also hosted in 2024 which developed the newest instructors in this skill set for the Country. The Training Centre is unique as it can host two and sometimes three courses being ran simultaneously. Courses were hosted in the facility for firefighters from Carlow, Clare, Cork City, Cork County, Kerry, Kilkenny, Laois, Limerick, Louth, Meath, Offaly, Tipperary, Waterford, Westmeath, Wexford and Wicklow Fire Services as well as the Irish Air Corps and Irish Defence Forces. The LASNTG (Local Authority Services National Training Group) hosts regular QQI accredited Training Courses in Firefighting Skills, Breathing Apparatus and Compartment Fire Behaviour in the Training Centre. In total, Hacketstown Training & Development Centre hosted training courses for a total of 308 days during 2024 for over 500 firefighters. The number of training courses hosted in Hacketstown will see an increase in 2025 due to the additional 400 retained firefighters being recruited nationally as a result of the recent WRC Recommendation.

Rescue Organisation Ireland

The Rescue Organisation team continued training throughout 2024 and competed in the national competition. The team have reached out to new members from within the County Fire Service during the year.

Major Emergency Management

Carlow County Fire & Rescue Service worked in collaboration with our Partner Response Agencies within the South-Eastern Region maintaining the Councils ability to carry out its functions in any Major Emergency that might be declared. The County Fire Service and Carlow County Council staff played an active part on regional working groups throughout 2024. New Council media liaison Officers were trained, and the Councils Major Emergency Plan was updated in 2024.

The County Fire Service led out on the largest regional major emergency exercise in a decade with Partner Response Agencies delivering a simulated commercial aircraft crash on Mt. Leinster on the 2nd October 2024. This exercise involved over 150 emergency service staff from across the region including the Primary Emergency Services, Voluntary Emergency Services and strategic managers from the Primary Response Agencies. This simulation also included exercising Carlow County Councils Major Emergency Plan which was updated in 2024. Footage from the exercise will be used to develop new Major Emergency training materials for use across the Country.



Climate Action

Carlow County Fire & Rescue Service continues to support Carlow County Council's Climate Action Plan to achieve the target of reduction of 51% of carbon output by 2030. The County Fire Service introduced further Climate Action measures during 2024, all staff completed the LASNTG Climate Action training, petrol-powered Road Traffic Collision Extrication Equipment and Positive

Pressure Ventilation Fans were replaced with battery operated equipment further decarbonising the Fire Services equipment and reducing carbon output.

The Hacketstown Training & Development Centre continues to be managed for wildflowers, biodiversity with beehives installed in the wildflower area which has seen a number of swarms make their home there. It is hoped this measure will improve biodiversity in the Hacketstown area. In 2024 the County Fire Service also took delivery and put into service the first ECO Class B Fire Appliance in Ireland. This Fire Appliance combines the use of Hydrotreated Vegetable Oil instead of diesel with solar panels and vehicle software which charge auxiliary batteries to power battery operated equipment and the emergency blue lights at incidents. This allows the Fire Appliance engine to enter standby mode when stationary for extended periods of time reducing carbon output. The County Fire Service is also working on developing further new innovative technical solutions to reduce the carbon output from our operational fire service vehicles and equipment in the future.

National Directorate for Fire & Emergency Management National Resilience Fleet

Carlow County Fire & Rescue Service continues to support the work of the National Directorate for Fire & Emergency Management through the management of the Directorate's fleet of 13 Resilience and Training Fire Appliances. These 13 fire appliances are managed and maintained through Carlow County Fire & Rescue Service and are used by the National Directorate for the delivery of the Fire Service National Training Programme across Ireland for fire officers at all ranks from Recruit to Senior Fire Officer ranks.

Public Lighting Energy & PLEEP Improvement Costs aving a good road and rail network is integral to the economic prosperity of a county. It is essential to have good access to the capital, the ports, and the large towns of the region. For local economic, social and recreational purposes it is also essential that the regional and local road asset base is maintained to the highest possible standards consistent with available funding.

The policy of the Council is to maintain, develop and improve existing roads and to construct new roads as financial resources permit. The administrative area of Carlow has a road network of 1,329 km (comprising of 24km of Motorway, 54 km of National Secondary, 186km of regional and 1,078km of Local roads.

Motorway Network

Transport Infrastructure Ireland (TII) manages and provides funding for all motorway schemes.

National Secondary Road Network

Transport Infrastructure Ireland (TII) provides funding for national roads. In 2024 Carlow received an allocation of €2,180,268 for maintenance and improvement works for bridges and carriageways, and to meet costs associated with supervision, public lighting and general maintenance of the national road network. Subsequently, Carlow County Council applied for and was awarded additional funding for maintenance and improvement schemes on the National Roads in the amount of €186,500.

Regional & Local Road Network

The Department of Transport provides funding for maintenance and improvement works on Regional & Local roads. In 2024, Carlow received an allocation of €7,935,450 for improvement works and general maintenance of the non-national road network. This programme targets much needed remedial measures on regional and local roads in the county under the following:

Surface Water Drainage Remediation

National Road - Pavement Improvement Schemes

Following a comprehensive survey of the national road network throughout the county, several locations were identified requiring significant remedial action. These large projects typically in excess of €200,000, are assessed & designed to inform the Pavement Asset Repair & Renewal Report which sets the scope of the schemes for funding, tender and completion. The schemes undertaken in 2024 included:

- → Completion of the N80 Rathcrogue to M9 Scheme for circa 3.2km
- → Completion of the N80 Clonmackshane to Ballykealy Scheme for circa 3.9km
- → N81 Bough to Co Bounds Scheme for circa 2.8km

N80 Leagh Bends Scheme

Carlow County Council is committed to roads infrastrcutrue and safety improvements and has progressed a number of sections on the national network for improvement over the years. A 3km section of the N80 was identified for realignment from the townland of Graiguenaspiddoge to the townland of Castletown, traversing the

townlands of Leagh or Ballybeg, Kilballyhue and Kilcoole all in the County of Carlow, including all ancillary works associated therewith. Following extensive survey, design and consultation on Tuesday 3rd December, Carlow County Council formally submitted the Section 177AE Planning Application and Compulsory Purchase Order Application to An Bord Pleanála for consideration.


Specific Improvement Project - R448 @ Royal Oak Road Junction

Following completion of a study at the junction between the Regional Road, R-448 and the Regional Road R-724, locally known as the Royal Oak Junction 4 potential options were developed for the improvement of the Junction. The members of Muinebheag Municipal District agreed to proceed with a Section 38 application for Option 1: Junction Tightening and Traffic Calming at their meeting in December 2024. The scheme introduces measures to manage traffic flows, undertaking improvements to pedestrian & cyclist facilities throughout the area. (Figure 3.1 attached)

Strategic Improvement Project -Carlow Southern Relief Road

In August 2021 Carlow County Council submitted the Carlow Southern Relief Road Strategic Assessment Report to the Department of Transport for consideration and on the 1st of December 2021 received approval to proceed to Preliminary Business Case development. Since the engagement of Project Manager in December 2023, great progress has been achieved with the completion of tender process for the engagement of Technical Consultancy Services for the Carlow Southern Relief Road Phases 1-4 as set out in the TII Project Management Guidelines.

Bioretention Areas (Rain Gardens)

The bioretention gardens at the junction of the Old Dublin Road/Railway Road were entered in the prestigious European competition celebrating environmental excellence at local level. This is a Europewide competition for villages, towns and cities where communities and public bodies highlight the importance of the green environment to improve people's quality of life. Carlow County Council's initiative was awarded overall Gold Award, the President's Prize for the town's rain garden development and a Special Characteristic Prize for the Delta Sensory Garden. It was also shortlisted for LAMA Awards 2025 for Best Environmental /Ecological Initiatives Category.

Noise Action Plan 2024-2029

Carlow County Council being the designated Action Planning Authority under the Environmental Noise regulations reviewed its existing plan and prepared a new noise action plan aimed at the strategic long-term management of environmental noise from

major roads (more than 3 million vehicles a year). It does not apply to noise from domestic activities, neighbourhood noise, noise at workplaces or noise inside means of transport. The Carlow County Council Noise Action Plan 2024 – 2028, supported by Noise Consultants Limited, for sections of major roads in County Carlow, was made on the 18th December 2024, and a copy of the Noise Action Plan and associated documents including a link to the Round 4 mapping is available to view on the Council Website Noise Action Plan | Carlow Co Co.

This Noise Action Plan is supported by a four-year programme for implementation (2024-2028), with progress reported to the Environmental Protection Agency on an annual basis. It is underpinned by a set of overarching noise policy principles outlined in the Noise Policy Statement. These noise policy principles are supported by a series of Responsible Aims for managing noise issues within Carlow County.

Default Rural Speed Limit

The national speed limit review published in September 2023, consisted of 28 recommendations, including the changing of the national default rural speed limit from 80km/hr to 60km/hr. The members of Carlow County Council at their meeting of July 2024 agreed to implementation of the default rural speed limit on all local roads in County Carlow. The Statutory Instruction to implement Section 7 in the Road Traffic Act 2024. which legalises the reduction in the default speed on rural local roads on the 7th February 2025, was signed by the Minister of Transport, on 6th November 2024.

Public Lighting Energy Efficiency Project (PLEEP)

All local authorities are in the process of converting their public lighting to LED luminaires. This change in technology will improve energy efficiency, cut costs and reduce CO2 emissions. To date, 4,219 of a total number of 6,733 Public lights in County Carlow have been converted to LED luminaires.

Active Travel

Active Travel is "travelling with a purpose using your own energy". Generally, this means walking or cycling as part of a purposeful journey and can also include the use of non-motorised scooters which are increasingly being used for urban transport, especially by school children. So, walking as part of a commute to work, cycling to the shop or scooting to school are all considered active travel, whereas walking or cycling for purely leisure purposes is not.

Active Travel is a positive climate action and is seen as a critical component of Ireland's Climate Action Plan. The delivery of Active Travel projects will contribute to tackling climate change by providing the opportunity to use "green" and sustainable transport options. Walking or wheeling instead of travelling by car is a great way to reduce our impact on the climate.

In December 2023 the National Transport Authority (NTA) invited applications from Carlow County Council (CCC) for schemes to be considered for funding under the 2024 Active Travel Investment Programme. In February 2024 the NTA allocated funds of over €290M to Ireland's local authorities for the provision of walking and cycling infrastructure. CCC received an allocation of approx. €3M for the delivery of projects across the county. The following table shows the amount spent on each Active Travel project in 2024.

Special Projects

Carlow County Council's Special Projects Division is comprised of two separate teams encompassing Capital Works and The Carlow Town URDF Project.

The teams are involved with a diverse range of initiatives, encompassing both large-scale, multi-million-euro projects funded by the **Urban Regeneration and Development Fund (URDF)** and smaller projects funded by the **Rural Regeneration and Development Fund (RRDF)**, the **Town and Village Renewal Scheme**, and CCC's own resources.

Capital Works

In September 2023, the Capital Works Team was re-established and managed several capital works projects through the various stages of development.

- Tullow Courthouse €200K
- → Management of construction phase to refurbish roof, windows and doors on this listed structure part funded by an Historical Structures Fund (HSF).
- County Buildings Carpark €700K
- → Provision of 90 spaces.
- → Designed, procured the construction and completed the delivery of the project on site.

- → Public Realm enhancement at Market Square.

- → Design in-house and Part 8 submitted in December.
- → Procurement of construction phase commenced.
- Carlow Library Roof & Chimney Repair €500K
- → Procurement of construction phase.
- → Contractor appointed.
- → Works to commence Q1 2024 part funded with HSF Grant.
- VISUAL Public Realm Enhancements €500K
- → Public Realm Enhancement works at VISUAL.
- → Part Funded by Fáilte Ireland, Procurement and Management of construction stage.
- Heritage & Trail Way finder Signage €250K
- → Interpretive and wayfinding signs in Carlow Town.
- → Part funded by Fáilte Ireland.
- → Signs designed, procured and contractor procured to install.

In addition, the team assist with technical guidance and supervision with other sections including the "Sky Lakes' project by the Arts Office in Carlow Town Park and the development of Enterprise Centres at Hacketstown, Bagenalstown and Carlow with the LEO office.



Carlow Town Urban Regeneration Development Fund (URDF)

Carlow Town URDF aims to revitalise and rejuvenate the town, creating a thriving urban centre that meets the needs and aspirations of the community.

The total value of Carlow Town URDF projects is €22.78M, 75% of which would be grant aided through the URDF fund.

This fund focuses on the following projects, creating a more compact, sustainable, and vibrant core:

The projects will be delivered in two bundles.

The first is the Rail Link Project, which will be delivered by Carlow County Council's own in-house Design Team. The second is the Town Centre Project, which will include the rest of the funded URDF projects.

In June 2024 Carlow Co Co successfully completed the Part 8 planning process. We are currently finalising the construction tender which is due to be published mid 2025. The project is due to be completed in 2026.

In October 2023 Carlow County Council announced the appointment of Urban Agency as the external design team for the Carlow Town Centre Project, marking an important milestone in the transformation and enhancement of Carlow Town.

Urban Agency are responsible for developing a comprehensive design proposal that encompasses architectural design, landscape design, urban planning, and the integration of sustainable practices.

The has been extensive public consultation at all stages of the project process, from its inception with "Carlow 2040", during the design process through "Your Carlow" and through the statutory Part 8 planning process.

The Part 8 process is due for completion in Q2 2025.

In addition, the team assist with technical guidance and direction with other sections including the "Destination Towns" project with the LEO office, conservation advice with the Active Travel team, the THRIVE application with the regeneration team, as well as consulting with the planners on some town centre planning applications.







arlow County Council is the Civil Defence Authority for the administrative area of County Carlow. The 2003 Civil Defence Act sets out a number of roles for Civil Defence. Among these roles are providing a backup service to the Primary Emergency Services; Community Service; Training in Casualty; Radio Communications; Rescue; Welfare; Fire Fighting and Boating Skills (search and recovery). Civil Defence also provides service to the Local Authority, Health Service Executive, and the Gardai in the event of severe weather conditions such as flooding and snow. Civil Defence also provide in emergency situations Radiation Monitoring.

The Major Emergency Management
Framework document also sets out roles
and responsibilities for Civil Defence in the
event of emergencies, such as setting up
Welfare Centres, Registration of Casualties,
responsibility with HSE for transportation to
various Hospitals and Secondary Line back
up to the Principal Response Agencies.

The members of Carlow Civil Defence are all volunteers except for the Civil Defence Officer who is employed as CDO on a parttime basis by Carlow County Council. At present we have over 34 volunteer members ranging from locations such as Carlow town, Muinebheag, Borris and Rathanna. Weekly training on subjects such as First Aid to CPR level, First Aid Responder, Emergency First Responders, Emergency Medical Technician, Fire Fighting skills, Swiftwater Rescue techniques, Technical Rescue, Search Skills, Welfare etc., are taught and practised. On our training schedule at weekends the subjects taught are exercised and the skills resulting from this are pitched against other counties in competition at various venues.

Also our training at field days are used for searching in open country, AFS fire fighting events, and Search Skills training on land and with boats in the river Barrow and Slaney. The Civil Defence Headquarters, completed in September 2009, is fully operational, making the Carlow operations more efficient and so providing an effective and quick response.

In 2014 Carlow Civil Defence rolled out a new Search Skills Training Course for its volunteers. It was taught in the Garda College and Carlow volunteers were among the first to embrace this activity and we gained status to Instructor level. Since mid-2014 we also have Instructor level at Water Awareness and Swift Water

Civil Defence Boat units provide back-up assistance to the (PRAs) Fire service and Gardai in River Search and Recovery (RSR) situations. Volunteers are trained in Boating skills, River and land search and recovery techniques for back up situations to Gardai. Water awareness and Swift Water Flood Response courses are run throughout the year.

Carlow Civil Defence were involved in the Setting up of Rest Centre for the arrival of Displaced persons from War torn Ukraine and continue to help as required during 2022 and are available in the event of any emergency.

In 2020 Assistant Civil Defence Officer (Part time) was also appointment to help with all the new duties and call outs.

A new Voluntary Emergency Management System computer registration system known as VEMS was rolled out this year to manage volunteers in training courses, Equipment, Vehicles and the management of all operations.

Drone Operations

Carlow Civil defence operates drones in the Open Category operating under the IAA registered organisation 'Carlow County Council'.

Carlow Civil Defence currently operates three different drones manufactured by DJI. The three drones are different sizes and have different roles. Drone technology is always changing and improving and we are keeping up with this by upgrading our drones and equipment. In 2024 a new mobile charging unit was added to our equipment and in 2025 the Civil Defence College are planning to replace our largest oldest drone with a new DJI Matrice M30T at a cost of approx. €15,000. There are currently three trained pilots in Carlow Civil Defence and we have a number of support staff trained also.

New Build Programme 2024

An overall delivery of 94 new build units was achieved in 2024. This includes a combination of Part V new build units, AHB Turnkey, Local Authority Build and Buy and Renew (Conversion of Vacant/Derelict Units). The build target under Housing for All was 92.

Acquisitions/Tenant in Situ Purchases

In 2024, 58 properties were purchased throughout County Carlow. 20 properties were secured under the tenant in situ scheme, preventing eviction. Other acquisitions included START, Housing First, Long Term Complex and Aftercare Programmes, and housing designated for Traveller Accommodation, Disability, and Elderly needs.

Private Grants

A total of €2,905,419.00 was allocated under Private Grants Schemes, including Housing Aid for the Elderly, Mobility Aid Grants, and Housing Adaptation Grants. This represents 325 approved grant applications, ensuring essential upgrades and repairs to homes, allowing elderly and disabled individuals to remain in their residences longer.

Energy Efficiency Retrofit Programme (EERP)

Carlow County Council's target remains 490 properties by 2030. In 2024, 78 properties were completed. A total of €2,532,746 incl VAT was invested, averaging €32,471.10 incl VAT per unit. Works included insulation, window/door replacements, heating system upgrades, and other energy improvements, aiming for a B2 BER Rating.

Casual Vacancies/Relets

In 2024, 41 vacant units were returned to stock. The average turnaround time was 15.96 weeks, ensuring properties met private rental standards before reallocation.



Housing Stock

The Council housing stock increased by 102 in 2024, bringing the total to 2129. This includes additions through new builds, acquisitions, and improvement programs, with 4 properties removed due to sales, expired programs, or decommissioning.

Housing Applications/Transfers

There were 417 new applications for housing supports in 2024, alongside 93 transfer applications. The Housing Department continued processing valid applications within 12 weeks.

Housing Assistance Payment (HAP)/Rental Accommodation Scheme (RAS)

The number of active HAP tenancies at 31/12/2024 2024 was 566, reflecting decrease of 46 active tenancies from 31/12/2023. The number of RAS properties decreased to 276 over the same period in 2023.

Homeless Services

Carlow County Council remains part of the Southeast Homeless Region, implementing the 2022–2026 Homeless Action Plan. In 2024, there were 486 homeless presentations, an increase of 146 from 2023. Homeless prevention efforts assisted 339 cases, diverting them from emergency accommodation. Emergency placements increased by 51 adults and 13 children,

totalling 144 adults and 38C individuals receiving full care and case management.

Tenant Liaison & Anti-Social Behaviour

In 2024, 164 complaints regarding antisocial behaviour were received, with 8 cases leading to legal actions or eviction proceedings. The Tenant Liaison Team expanded, focusing on proactive tenancy management and new tenancy success programs.

Mortgage Services

The Housing Department received 34 applications for local authority home loans in 2024, with 15 approved in principle. A total of €1,867,300.00 was drawn down during the year.







Local Authority Integration Team

A Local Authority Integration Team was established in May 2024 with the role of the Integration Team being to provide advice, guidance and information to empower International Protection Applicants and **Ukrainian Beneficiaries of Temporary** Protection to live indepen A Local Authority Integration Team was established in May 2024 with the role of the Integration Team being to provide advice, guidance and information to empower International Protection Applicants and Ukrainian Beneficiaries of Temporary Protection to live independent lives within the County of Carlow. The Integration Team works in partnership and collaboration with multiple agencies including government departments, state agencies, NGO's and Volunteer Groups in fulfilling the integration role.

In supporting the New Arrivals, the Integration Team hold information clinics in all accommodation centres throughout the County with 29 clinics being held in 2024.

Several events were held in partnership with other agencies during 2024 as follows:

- → Multi-Cultural Supper Club where new arrivals could experience food, music and dance from other cultures.
- → Stay and Play is a programme for 3 to 6 years of age where children experience song, rhythm and dance.
- → Christmas Cinema.

Community Integration Forum

The Community Integration Forum was established in 2024 to provide strategic leadership in co-ordinating supports and services locally to International Protection Applicants and Beneficiaries of Temporary Protection newly arrived in County Carlow. The membership of the Community Integration Forum consists of representatives of Community, Statutory and Voluntary agencies working in partnership to provide key integration supports. A total of 9 meetings of the Forum were held during 2024.

Two sub-groups of the Community Integration Forum were formed during 2024 namely a mental health sub-group and an Integration Support Workers sub-group. A total of 9 meetings were held during 2024.



Community Recognition Fund

The Community Recognition Fund is a scheme funded by the Department of Rural and Community Development introduced to support the development of community facilities in towns and villages hosting the majority of new arrivals. Projects approved under this scheme are for the benefit of all members of the community. Outlined below are the projects that received funding during 2024:

Offer A Home Scheme

The Offer A Home Scheme is a government initiative, led by local authorities, whereby property owners offer vacant houses, apartments and holiday lets to the Local Authority to accommodate Ukrainian Beneficiaries of Temporary Protection. During 2024 this scheme provided accommodation to 145 Ukrainian persons in County Carlow.

Rest Centre

A Rest Centre to provide temporary accommodation facilities to Ukrainian Beneficiaries of temporary protection arriving in Ireland was operated by Carlow County Council from April 2022 until the Rest Centre closed in March 2024. A total of 772 Ukrainian persons were accommodated in the Rest Centre during that period.

The Carlow Pride of Place 2024 competition was launched in Ballykealy House with a Workshop form Gary Graham. Speakers at the workshop also included Laura Kelly, Community Development Officer; Shane Casey, Environmental Awareness Officer; Aine Byrne, Community Climate Action Officer.

A total of 143 applications were submitted across various categories, and the enjoyable yet challenging task of judging took place throughout the summer.

The Pride of Place awards night was held on 5th December 2024, with a full-capacity audience in attendance. Communities across County Carlow were praised and thanked for their efforts. Numerous prizes were awarded to the hardworking groups, with the overall winner in the Towns and Villages category

going to the community of Rahanna, and the overall winner in the Estates category going to the New Oak Residents Association. A new category, the Community Project Award, was introduced to the 2024 competition to recognize innovative projects and efforts within communities that did not fall under the existing population categories. The overall County Winner of this award was An Gairdín Beo, Carlow.

The prestigious Michael Deering Cup was awarded to Hacketstown Biodiversity Garden, while the Individual Award was presented to Pat Mealay of Carrigduff recognizing his years of hard work and dedication. The Council awarded over 60 prizes, to community groups throughout the county. The prize categories included Towns & Villages, Resident Associations, Community Project Award, Front Garden, Commercial Premises, Individual, and Youth Awards.









IPB Ireland Pride of Place

On Saturday, November 2nd, 2024, Monaghan's Hillgrove Hotel hosted the prestigious IPB Pride of Place Gala Awards Ceremony, marking the 22nd year of celebrating community and resilience across Ireland

The IPB Pride of Place competition honours communities that work tirelessly to improve daily life for residents and build stronger, more resilient neighbourhoods. Every year, communities from across Ireland showcase their initiatives, sharing how they've come together to shape positive change.

The Carlow Elderflower Garden Club, nominated in the Age Friendly Communities category, developed an exceptional urban space notably called 'A hidden Gem' that is not only educational, sustainable, and accessible, but is also a social outlet and a haven for older residents. The project won a special award for impressing judges with innovative use of space.

The Bagenalstown Area Community Development Group were nominated in the Creative Communities category, as they showcased 'Bagenalstown in Bloom' a fantastic community-driven initiative that highlighted the rich heritage of Bagenalstown while promoting a whole of community approach to getting people involved.

Environmental/Amenity Grant Scheme 2024

A total of 122 grants were awarded to community groups, residents' associations, and schools across the county. The projects funded included:

- → Landscaping and development of open spaces,
- → Amenity development along river and stream banks,
- → Environmental protection and enhancement, including the promotion of biodiversity, recycling, waste minimization, and water harvesting.

In 2024, grant funding of €65,080 was distributed.

Discretionary Funding 2024

Elected Members awarded a total of 289 grants from their Discretionary Funds to Resident Associations, Tidy Towns Groups, Community and Voluntary organisations, schools, and sporting organisations, amounting to a total value of €147,102.18.

Carlow Local Community Development Committee (LCDC)

The LCDC is comprised of 19 members, both statutory and non-statutory, including four elected members. The Chairperson is Ms Lynda Stacey.

Following the Local Elections held in June 2024, Cllr. William Quinn and Cllr. Tom O'Neill were replaced by Cllr. Fergal Browne and Cllr. Any Gladney.

The LCDC/LAG has programme oversight and programme management in respect of the following programmes/activities:

- → Social Inclusion Community Activation Programme (SICAP) 2024 2028
- → Local Economic and Community Plan 2023 - 2029
- → Healthy Carlow
- → Local Enhancement Programme 2024 in which €142,867,38 of capital funding was provided to support community groups.

Local Economic & community Plan (LECP) 2023 - 2029

At the Council meeting on Monday, 13th November 2023 the Carlow LECP Framework Document 2023–2029, along with the 2-year Implementation Plan, received formal approval.

The LECP will be carried out through three consecutive two-year implementation phases. The first, the Carlow LECP 2023-2025 Implementation Plan, presents a detailed strategy to promote sustainable economic and community development in County Carlow. This plan is structured around six High-Level Goals (HLGs), each focused on critical areas such as sustainability, community empowerment, inclusivity, education, economic resilience, and infrastructure development.

Rural Development Programme 2014-2020 (LEADER) and LEADER Programme 2023 -2027

The funding allocated to County Carlow under the LEADER programme 2023-2027 is €4,968,715, under the following themes:

- → Theme 1: Economic Development and Job Creation;
- → Theme 2: Rural Infrastructure and Social Inclusion:
- → Theme 3: Sustainable Development of the Rural Environment and Climate Change Mitigation and Adaptation

The LEADER Programme was officially launched by the Implementing Partner, Carlow County Development Partnership CLG, on September 3rd, 2024, with a significant turnout at the event. Speakers on the night included Cllr Fergal Browne, Cathaoirleach of Carlow County Council, Eileen Doyle, Chairperson of Carlow County Development Partnership CLG, and past recipients of LEADER grant aid – PL Curran representing St Laurence O'Toole Athletic Club and Mary White of Blackstairs Eco Trails.

Carlow County Development Partnership CLG invited calls for 2025 under the themes of Economic Development Job Creation, Rural Infrastructure and Social Inclusion, Sustainable Development of the Rural Environment and Climate Change Mitigation and Adaptation

Social Inclusion and Community Activation Programme (SICAP)

The Social Inclusion and Community
Activation Programme (SICAP) is the
successor to the Local Community
Development Programme. SICAP is a locallydriven social inclusion initiative aimed at
supporting the most marginalized groups in
Irish society.

2024 marked the first year of the SICAP Programme for the 2024-2028 period, following the previous SICAP Programme (2018-2023). The LCDC serves as the contracting authority, while Carlow County Development Partnership acts

as the Programme Implementer. For this programme, County Carlow is is one Lot for the purposes of this programme.. The budget for 2024 was €700,184.00. Additional funding for New Arrivals was received in 2024 in the amount of €194,316.00.

Local Enhancement Programme 2024

The Department of Rural and Community Development's Local Enhancement Programme (LEP) 2024 provided capital funding to assist community groups across Ireland. This funding was aimed at supporting groups, particularly in disadvantaged areas, to carry out essential repairs and improvements to their facilities, purchase equipment such as tables, chairs, tools, signage, laptops, printers, lawnmowers, canopies, training equipment, and more. The funding enables communities, community groups, and committees to continue delivering valuable services to local residents while strengthening community connections. Additionally, the programme aims to support local strategic priorities by aligning with Local Economic Community Plans (LECPs).

The total funding amount for County Carlow included:

- → €119,056.15 in capital funding for the Local Enhancement Programme, to be used for repairs, facility improvements, energy efficiency projects, equipment purchases, and more.
- → €23,811.23 in capital funding specifically designated for Women's Groups.

Carlow LCDC approved, in accordance with the Department's guidelines, that the Capital Fund be divided with 70% targeted funding through the Social Inclusion Forum and 30% funding for grants of €1,000 or less.

In total 83 community groups/organisations received funding across the three Municipal Districts.

Community Development

The Community Development Officer collaborated closely with community groups,

residents' associations, and organizations in throughout 2024.

The Community Roots Programme initiative was developed in 2024 by Laura Kelly, Community Development Officer. This is a Youth Leadership programme in collaboration with Carlow County Council Community Section, Carlow Regional Youth Service, Carlow County **Development Partnership and Carlow Sports** Partnership. A countywide workshop held in Bagenalstown Community Garden launched the programme in October as part of Climate Action Week. Weekly programmes took place in Tullow and Bagenalstown to facilitate team building and youth leadership training. 20 Young people involved completed First Aid, Manual Handling Training and Child Protection Awareness Training. Young people had opportunities to volunteer in their local community as part of the Pride of Place awards and they also engaged with local community groups, mens shed, garda and elected members.

Bagenalstown in Bloom held in June 2024 is a vibrant community-driven event organised by the Bagenalstown Area Community Development Group. The showcases a diverse array of activities, workshops, and entertainment, appealing to all age groups and interests. KCETB, Carlow County Council and Carlow Development Partnership all provide funding and support to these events which are managed and delivered by Bagenalstown Area Community Development Group. Bagenalstown in Bloom was promoted at Bord Bia Bloom and on Local Radio as part of Carlow Mental Health Associations Hello Carlow How Are You? The event has significantly contribution to the community spirit, attracting visitors to Bagenalstown and providing a platform for local artists, children, and families to showcase their talents and efforts. Through diverse workshops and activities, Bagenalstown in Bloom fosters creativity, physical activity, and community collaboration, making it a highlight in the town's annual calendar.

In April 2024, 275 children and their families attended **Community Easter Egg Hunts** on Easter Sunday and Easter Monday in Coppenagh House Farm, Tullow and St Mullins, Carlow respectively. Both events offered families an opportunity to engage in a community based treasure hunt which was organised by local community groups and supported by the community section.

In December 2024, the Community
Development Section collaborated with
Carlow Regional Youth Service, The Carlow
County Council Integration Team and Healthy
Carlow to provide two **Outdoor Cinema**events in The Exchange Carlow in the lead up
to Christmas. This initiative was rolled out to
promote positive wellbeing and to support
families to have an opportunity to visit
Santa and enjoy a cinema experience while
also learning about Carlow Regional Youth
Service and the supports they have to offer.

The "Art Through Nature - Creative Ireland Pilot Programme" in Hacketstown was held in collaboration with the Community Section for four weeks in July with 12 participants attending this intergenerational project.

Playday which was organised in collaboration with Sports Partnership and Healthy Carlow, took place on July 20th

2024, with approximately 340 children participating.

The Bunclody Family Fun Day, hosted by the Bunclody Recreational Committee on June 9th 2024 had 200 families attending.

Age Friendly Carlow

Age Friendly Carlow, part of the national Age Friendly Ireland network and supported by Carlow County Council, is guided by an interagency Alliance chaired by the Chief Executive . The Alliance, which includes representatives from public sector organisations, community agencies, and the Older Persons Forum, met in 2024 to enhance planning and services for older adults in County Carlow.

Key achievements in 2024 include:

- → Completion of the review of the Carlow Age Friendly Strategy 2017-2022.
- → Production of the "Having Your Say" research report, which summarizes public consultations for the new 2025-2029 strategy. Consultations included online surveys, public meetings, and interviews with key populations, such as travellers, low-income households, and non-Irish nationals. The findings from this

- report will shape the upcoming strategy to improve services for older adults in County Carlow.
- → Strengthening the Carlow Older Persons Forum by aligning it more closely with national Older People's Council guidelines and enhancing the development and implementation of key actions within the community.

In 2024, three Alliance meetings were held to oversee the review of the previous strategic plan and manage the public consultation phase for the new plan. The Carlow Older Persons Forum, with support from the Alliance, Healthy Carlow, Carlow County Development Partnership, and UPMC, organized the Living Well Expo on October 22nd. This free event showcased over 40 exhibition stands from local organisations, including An Garda Síochána, HSE, SETU Lifelong Learning, VISUAL, Carlow Volunteer Centre, and the Alzheimer's Society of Ireland. Attendees had the opportunity to connect with various service providers and discover resources that promote healthy, fulfilling, and active lifestyles

Comhairle na nÓg

Comhairle Na nÓg members selected "Dicscrimination" as their key theme for 2024. To communicate their actions on this important topic, they produced a range of outputs, including podcasts, leaflets, and social media campaigns.

In 2024, Comhairle na nÓg Carlow held 14 meetings, with notable achievements throughout the year. One key output was the launch of their 'Tru You' podcast. The group won a Garda Youth Award in June, recognizing their outstanding contributions.

On July 10th, National Executive Isabel and two members attended the annual Comhairle na nÓg Regional Networking event, where members from different regions gathered to discuss topical issues. The group also partnered with Kilkenny Comhairle on the "Not Around Us" campaign, supported by Healthy Carlow.

Franek Dobronski represented Carlow at the Oireachtas as part of the "Local Champions"

program, which teaches young people to lobby for youth work funding.

€25,000 funding under the Comhairle na nÓg Development Fund 2023 from the Department of Children, Equality, Disability, Integration and Youth (DCEDIY) to support the operation and facilitation of Carlow Comhairle na nÓg was secured.

Carlow Traveller Interagency Group

The Carlow Traveller Interagency Group works to ensure that statutory agencies and state-supported initiatives providing services to Travellers focus on enhancing the integrated delivery of these services. The group is facilitated by the Community **Development Section of Carlow County** Council, with support from the Department of Justice, Equality, and Law Reform. Outputs for 2024 included the implementation of the Carlow Traveller Interagency Group Strategic Plan 2023-2026, providing support to the interagency and cross-departmental participation in strategy actions, securing funding from Dormant Accounts for Traveller cultural awareness training, and liaising with Department on reporting and funding requirements. €18,228 from the Department of Children, Equality, Disability, Integration and Youth linked to the Carlow Traveller Interagency Group was secured. The Department of Children, Equality, Disability, Integration and Youth provided a grant of €18,228.00 under the terms and conditions set out in this Agreement for the implementation of the project for services for Traveller and Roma Initiatives.

Healthy Carlow

2024 is the second of a three-year strategy for Healthy Carlow. All programmes supported under Healthy Ireland funding for the duration of the strategy are focusing on increasing levels of positive mental health and wellbeing, for those in our identified target groups: adolescents, older people, disadvantaged families and one parent families.

Healthy Carlow working collaboratively in 2024 to deliver a number of very positive





programmes. The following are some of the programmes:

Swimmin Women, A swimming programme for disadvantaged women and their children provides a safe space to engage in a social opportunity and encourage integration into communities; **Look Good**, **Feel Good**, a programme focused in self confidence and looking after appearance; **Youth Train** a physical activity programme to focus on methods of engaging in relaxing behaviours and social engagement in a positive manner; **Social Farming** giving disadvantaged people

an opportunity to undergo a supportive, healthy and inclusive experience on farm life; Decider Skills training for professionals in supporting individuals and families with coping mechanisms around wellbeing; Trauma Informed Practise Training increase professional knowledge and skillset in working with families and individuals who have experienced trauma; My Garden, My Fork supporting disadvantaged families to grow their own produce; Multi Cultural Supper Club fostering connection and understanding among diverse communities, celebrating cultural backgrounds;



Entente Florale Judging Day

Community Get Together's foster local social connection and raising awareness and engagement with community groups at a local level; Not Around Us; a campaign to de-normalise smoking and vaping around children and young people; Carlow Period Dignity a county wide campaign to tackle period poverty in Carlow including the provision of free period products and developing an identity around availability; Carlow Farmer Wellbeing a community wellbeing initiative aimed at supporting the health, safety and wellbeing of the Carlow farming community.

2690 people in Carlow engaged in programmes, training and events funded through Healthy Carlow in 2024.

Entente Florale European Competition

The Entente Florale Europe competition celebrates the importance of green environments and their role in improving the quality of life for communities across Europe. Carlow's success highlights the town's commitment to sustainability and sets a high standard for others to follow.

The Entente Florale Competition took place in Hungary on 7th September 2025. It was a proud night for Carlow as the town won a gold medal at the awards. In addition to the gold medal, Carlow was honoured with the President's Award for its Rain Garden Development and the Special Characteristic Prize for the Delta Sensory Gardens, recognizing the town's dedication to environmental excellence.

The awards reflect the hard work and commitment of the local authority, local organizations, community groups and volunteers who worked behind the scenes to make this achievement possible. Judges visited Carlow on July 12th and toured key locations, including St. Mary's Church Haymarket, Carlow Fire Station, Linear Park, Hanover Park, Carlow Town Park, Carlow College, Visual, St. Laserian's National School,

and Delta Sensory Gardens, all of which contributed to the town's success.

Carlow Public Participation Network (PPN)

In 2024, Carlow PPN received €120,700 in total funding, with €35,000 from Carlow County Council and €85,700 from the Department of Rural and Community Development. Carlow PPN had 358 active member groups across the Environmental, Social Inclusion, and Community & Voluntary Colleges.

The PPN had 32 community representatives on various boards and committees, including four Strategic Policy Committees (SPCs), the Local Community Development Committee (LCDC), Carlow Tourism Board, Joint Policing Committee, and Carlow Development Forum.

Carlow PPN participated in over 28 consultations and surveys on local and national issues, such as the Carlow Age Friendly Strategy, the Draft Heritage Plan, and the National Transport Authority.

To celebrate its 10th Anniversary, Carlow PPN hosted two Community Expo and Networking events, themed "Wellbeing in Your Community," in Carlow and Bagenalstown Municipal Districts, bringing together PPN members, local groups, and speakers to discuss topics of interest.

Africa Day

€7,400 towards the organisation of events to celebrate Africa Day 2024 was secured. Africa Day, designated by the African Union as an annual celebration of the continent's unity, falls on 25th May each year. The Department of Foreign Affairs has been the driving force behind Africa Day celebrations in Ireland since 2006 and Irish Aid supports a programme of community-based and policy-focused initiatives around the country on an annual basis.





arlow Arts Service plays a vital role in sustaining local arts development working closely with communities and artists across the county representing inclusion, diversity, and equality. We nurture and support our artists to help develop their artistic practice and processes.

In 2024 our four strategic objectives were:

Support to Artists Carlow Arts Office Programme 2024

Working in partnership with the Arts Council of Ireland €105,000 was secured. €5,000 of the budget was dedicated to an Artist Bursary that reaches artists under the Equity, Diversity, and Inclusion policy of the Arts Council of Ireland. Cairdeas Centre, Tullow were the worthy 2024 recipients.

Under the Arts Acts Grants for Artists, following a competitive assessment process a total of €17,600 was awarded with 10 artists receiving grants. Under the Arts Acts Grants for Community Groups 13 community groups were awarded funding totalling €22,400.

ArtLinks provides professional development opportunities and supports for established and emerging artists who are resident in the four partner local authority areas in the South East region. 2024 saw Carlow Arts Service support **9 Carlow artists** with bursary supports that totalled **€19,500**.

Carlow Live and Local

Following an Open Call, led by the Arts Service, **62 applications** were received from local Carlow Musicians to perform at Carlow Arts Festival as part of the Carlow Live and Local Programme. **82 Carlow Musicians** were supported by this initiative with **€30,000 in grant funding allocated.**

Breaking the Patterns

This new South -East initiative is led and supported by Carlow Arts Service, targeting emerging artists who are from socially disadvantaged backgrounds. The programme offers ongoing professional development training for artists, bursary supports and an opportunity to take up a European Artist residency. Within the competitive context from the Southeast region, 6 artists were selected to undertake a three-month artist residency in Seville Spain which featured **2 Carlow artists**. A further three-month artist residency in Lisbon, Portugal was delivered with 2 Carlow artists taking part. This project will continue to support emerging Carlow artists into 2025.

Other artists supported by Carlow Arts Service in 2024

- → Carlow Exchange Commissioned Artist -Local artist Kirstie Mahers' mural at The Exchange
- → Local film maker Frank Mannion on his Quintessentially Irish Film Premier at VISUAL.
- → Festival in a Van and local dance artist Roisin Whelan at Light Fest in Bagenalstown.
- → Musician Marian Gaynor with Sing to Care providing Carlow Day Care Centre attendees with 8 weeks of singing, percussion instruments, active participation, and movement.

Community Engagement County Carlow Youth Theatre

Managed by the Arts Service supported 2 groups of young people who met weekly in VISUAL aged 10-13 and 14-18 years. Participation took place in workshops and performances throughout the year as well as site specific performances during Cruinniu na nOg, with 48 young people from all around Carlow getting an opportunity to perform.

Music Generation Carlow

MGC continued to work across the county with participation of over 4,600 young people engaging in performance music education weekly, working in 24 local primary schools and 4 secondary schools along with community/outreach centres across the county. MGC's HUB programmes have now fully recovered to pre-COVID levels of participation with 5 HUBS across the county. In 2024, MGC introduced a new HUB in Bagenalstown, aimed at servicing the South Carlow area. All programmes operate during and outside school hours, both after school and on weekends — ensuring wide accessibility for families across Carlow.

Carlow Arts Festival

From 5th - 9th June 2024, Carlow town took centre stage for the 45th edition of CAF.

Over 22,000 people visited the festival to engage with the 89 performances and events, presented by 113 artists. Comprising of local, national and international artists, the festival presented work from a wide array of art forms including dance, literature, circus, spectacle, music, theatre, cinema, and visual arts.

Creative Ireland Carlow Programme

Total funding awarded to Carlow by the Creative Ireland programme for 2024 was €207,419. €30,000 of this funding was ringfenced for Cruinniú Na nÓg 2024 - National Day of Creativity for children and young people which took place on Saturday 15th June with 30 free creative events across the county.

Creative Ireland Carlow Programme 2024 proudly supported:

- → Specially produced Borris Lace Starter kits, developed and produced as part of the Creative Ireland Open Call 2023/2024 by the Borris Lacemakers.
- → The work of **St. Catherine's Traveller Support Services** "Crush On" project and ensuring inclusion within the Pan Celtic festival showcasing renowned Traveller Singers Trish Riley and Thomas McCarthy, in an event attended by **98 festival goers**.
- → Gnathoga Nadurtha Phase 2 project in collaboration with Drummin Bog, Rathangan Bog, Kildare and Girley Bog, Meath formed part of the Irish Museum of Modern Art's "Earth Rising Event", a festival of events aimed at addressing climate crisis. This project was shortlisted under the Chamber Ireland Excellence in Local Government Awards 2024 Sustaining the Arts and under the LAMA Awards 2024 Best Environmental Project.
- **→ 9 new and existing Rambling Houses** around Co. Carlow following a new open call providing €20,000 in grant supports.
- → The development of a new **initiative in Hackettstown** called "Art Through

- Nature" developed with the Biodiversity Garden in collaboration with Artist Mairead Holohan.
- → Muine Bheag Arts summer programme COMMUNE a programme of live events in the Muine Bheag Community Centre.
- → Summer School Forest School Workshops at VISUAL.
- → 15 Care Concerts in residential care homes and healthcare settings across the county with Mobile Music Machine.

Living Artfully

Creative Ireland Carlow and Kilkenny officially launched the "Living Artfully" programme on 25th September. Living Artfully is a two-year creative programme funded through Creative Ireland and aimed at supporting Creativity for Health and Wellbeing in our communities. Living Artfully invites service users and staff engaged with Traveller Support Services, Dementia Friendly services, Mental Health services, Social Prescribing services, HSE Carlow/Kilkenny to participate in this therapeutic intervention and health resource that offers a mechanism to instil creative, healthy, and helpful habits through engagement is this socially engaged arts initiative.

Place-Based Practice Take a Part Carlow

2024 brought rich collaboration with local artists. Community writer in residence Clifton Redmond led inclusive and inspiring writing workshops to a broad range of the Tullow Road Community, from young people aged 16-19 at Youth Reach, to St. Catherines Traveller Support Services members and community members at the Eire Og Club House through open-door writing sessions.

Artist Kate O'Shea then engaged with Clifton to develop a specially designed poetry broad sheet which looked at creative responses to the concept of displacement and featured writing from the multiple Tullow Road Community writing workshops. The Poetry Broad sheet was launched on Culture Night alongside an open mic style poetry reading night which featured local talent and newly commissioned performances by musician Duane Ayers.

Carlow artist Cian Kinsella developed a new project entitled "Serious Messin" for Carlow Regional Youth Services Tullow Road Youth Project after school programme.

Building local capacity in the community remained on top of Take A Parts objectives in 2024. The following activities helped bolster community ownership of the programme and capacity building amongst the Arts Action Group:

- → Members attended the Meet the Arts Council Sessions at VISUAL and talked about funding opportunities and supports to build capacity in the community.
- → Take A Part Carlow worked closely with Carlow Arts Service, Take A Part UK, Creative Places Bagenalstown and community members and artists to develop a "Creative Capacity Building Day" in Carlow. This event workshopped the Arts Action Group model, how local decision making has influenced the work of Take A Part Carlow and reviewed the Arts Action Group membership in terms of supporting the strategic development of this socially engaged arts programme.

Creative Places Bagenalstown

In 2024, the Creative Places Bagenalstown Programme enriched the cultural landscape of Bagenalstown with a series of vibrant projects. The highlight of the year was *The Lock Keeper's Memories*, an enchanting promenade performance created by Hugh W. Brown in collaboration with the young people of **Carlow Regional Youth Service** in Bagenalstown and the wider community. This unique theatrical experience celebrated local voices, history, and shared memories.

Another standout project was "A Musical Planet Looks Like...", an Augmented Reality (AR) Wall Mural by artist Paul Byrne in collaboration with Music Generation Carlow. An accompanying soundscape, crafted by Paul Brett and Gearoid O'Sullivan, added an auditory dimension.

Culture Night Bagenalstown drew large crowds and celebrated the town's cultural heritage. The Old Post Office hosted local Traditional Musicians, while the Fairgreen Park featured a family-friendly pop-up cinema produced by Joe Cleere / CCC Community Cinema.

Additionally, Creative Places Bagenalstown funded a **retractable lighting deck and sound system** requested by the community. This new resource is now available for use across the town, enhancing the quality and versatility of local events.

Culture Night

A programme of **41 free events** was devised by the Arts Service in collaboration with community and artists around the county to celebrate Culture Night on Friday 20th September. **€24,000** in grant funding was made available to support these events which comprised of Music, Song, Dance, Storytelling, Visual Arts, Literature, Poetry, Film and Theatre. Carlow Sports Partnership: A Year of Growth, Inclusion, and Community Spirit

In 2024, Carlow Sports Partnership continued to inspire and engage communities across the county, delivering **139 events and programmes** and engaging with **4,668 participants**. With a commitment to ensuring sports and physical activity accessible to all and to provide opportunities for people of all ages, abilities, and backgrounds to participate.

Throughout the year, older adults found joy and connection through programmes such as Forever Fit, Active Agers, and Wise and Well. These initiatives provided a space not just for movement but for friendship and well-being, helping participants stay active and socially engaged. The Go for Life Games became a highlight, bringing together groups from different areas to celebrate physical activity in a fun, relaxed, and inclusive environment.

Empowering women and teenage girls remained a key priority, with events like Her Outdoors, Women in Sport Week, and the Women's Hiking Series drawing significant interest. Women of all ages embraced new challenges, from hiking scenic trails to learning the fundamentals of strength training in the Introduction to Weightlifting for Teenage Girls sessions. One hiker reflected, "The Women's Hiking Series was an amazing experience. It pushed me out of my comfort zone, and the sense of achievement at the top was unforgettable."

Inclusivity was at the heart of the year's initiatives, ensuring that children and adults with additional needs had opportunities to participate in sport. Programmes like the **Delta Centre Walks, Inclusive Multi-Activity Camps, Inclusive FAI Football for**

All Camp, and Inclusive Basketball Camp created safe and welcoming spaces where every participant could thrive.

Outdoor adventure continued to be a huge attraction, with participants taking on activities like the Columban Way Walk, CYCLES, Stand Up Paddle Boarding for Teenage Girls, and the Street Velodrome Bike Week Event. Whether on land or water, these experiences encouraged people to embrace new challenges and enjoy the benefits of outdoor fitness. Additionally, community spirit flourished through events like the Bagenalstown in Bloom Family Fun Run, Wednesday Wanderers, and Wellbeing Playday, which brought families, friends, and neighbours together to celebrate movement and connection.











Carlow's young people were not left behind, as Carlow Sports Partnership continued its strong relationship with local schools and clubs. Initiatives such as **School Hall Athletics, Balance Bikes, and TY Girls Basketball** encouraged students to get moving, often giving older students leadership opportunities to guide younger children.

Safety and education remained central to Carlow Sports Partnership's work, equipping volunteers, coaches, and community leaders with essential training. Over the course of the year, Disability Awareness, Autism in Sport, CPR & Defibrillator Training, Sports First Aid, and Safeguarding Levels 1-3 were delivered, ensuring that local sports programmes were inclusive and well-supported.

Carlow Sports Partnership welcomed an **ESF+ Social Innovation in Sport Officer**,

who helped launch new initiatives like **Community Roots and Youthreach Badminton**, ensuring even more young people had access to sport and recreation.

With another incredible year of achievements Carlow Sports Partnership remains dedicated to fostering **inclusivity**, **engagement**, **and active living**.

The Board of Carlow County Museum held three meetings throughout the year. At the 17th Annual General Meeting of the Board Cllr Andrea Dalton was elected Chairperson for 2025 replacing Dr Seamus Ó Mhurchú.

Museum Appears on the RTE Today Show

On Wednesday March 27th, Dermot Mulligan, Museum Curator, appeared live in the RTE 1 television programme the Today show. The show was broadcast from the RTE Studios in Cork City. Dermot was interviewed by host Daithí O'Shea about a number of objects that were displayed specially for the broadcast including the wallet of Kevin Barry, the smoking pipe of Myles Keogh, the fossilised squid fossil, Lucinda Sly books and Corcoran's Mineral Waters. The Museum has received very positive feedback from both RTE and the public about the broadcast.



Carlow Town hosts the Irish Museums Association (IMA) Conference 2024

Over 100 museum professionals from across Ireland gathered in May in Carlow Town for the 2024 Irish Museums Association (IMA) Conference, under the theme "Beyond Boundaries - the future for regional museums". Carlow County Museum, on behalf of Carlow County Council, hosted the conference. The event highlighted the crucial and valuable role that local and regional museums play within their communities, showcasing their contributions to cultural heritage preservation, deep community engagement, and economic development. Representatives from over twenty museum sites and related industries provided insights into the significant work being carried out across regional museums and their profound connection to their localities and those that visit and reside in these. The conference, held in Carlow College, highlighted exemplary practice by museums working in this context.

Delegates celebrated Carlow County
Museum's 50th anniversary with a reception
hosted by Carlow County Council, taking
the opportunity to immerse themselves
in the local cultural offerings. Cllr Fintan
Phelan, Leas-Cathaoirleach of Carlow County
Council, said in welcoming the IMA to the
Museum that 'such gatherings as the annual
conference are important as they allow for
reflection, the generation of ideas, to hear
issues and explore latest thinking's and
probably most important, the development

of formal and informal friendships between institutions and their staff'.

Dr Seamus Ó Murchú, Chairperson of the Board of Carlow County Museum, informed delegates that Carlow County Museum has been through three generations; the pioneers of the Carlow Historical & Archaeological Society who set events in motion; the nine founders of the County Museum who brought the dream to life; and the present professional staff operating an accredited museum in collaboration with local volunteers. Each generation building on what went before, leaving a legacy for those to come.

John Shortall, County Librarian, presented a paper on Carlow County Museum titled Museum for the County: the County Council leading the Way, while Dermot Mulligan presented a paper on Breaking Borders: Saints Alive as Carlow Hops to Luxembourg! On the opening morning of the conference, Padraig Dooley, Museum Board Member, took delegates on a walking tour of Carlow Town. Carlow Tourism supplied the delegates with a conference bag with information about County Carlow and some Carlow produce.

Despite the positive developments, the conference underscored significant challenges faced by the regional museum sector. Gina O'Kelly, Executive Director of the Irish Museums Association, noted there are "serious core capacity concerns" stemming from the need for greater investment and cohesive policy frameworks. She noted







that "Many museums across the island are surviving in a policy vacuum. While they may successfully raise investment for public-facing programmes and exhibitions, concerns about understaffing and day-to-day operational funding remain an increasing priority – one that the development of a national museums strategy would seek to address".

The conference concluded with a renewed commitment to collaboration, innovation, and advocacy to ensure that regional museums continue to thrive and enrich their communities. Several of Carlow's other museums, Bishop Daniel Delany Museum, Tullow, and the St Mullins Heritage Centre, had delegates present at the conference.

Hopping Procession, Echternach, Luxembourg

Cllr Andrea Dalton, Cathaoirleach, Cllr John Murphy and Dermot Mulligan visited Echternach, Luxembourg, for the 2024 UNESCO Hopping Procession. Her Excellency Jean McDonald, Ireland's Ambassador to the Grand Duchy of Luxembourg, extended a Céad Mile Fáilte to the delegation. She held a reception for the delegation at her residence with many Irish people who live and work in Luxembourg.

The delegation and Ambassador McDonald visited Echternach on Monday and Tuesday May 20th and 21st where they were guided by Alain Muller, Willibrordus-Bauverein.







Mayor Carole Hartmann, Ville d'Echternach, and the Members of Ville d'Echternach, hosted a reception for the Carlow delegates. Later that evening the delegation attended the evening celebrations in the Basilica of St Willibrord followed by a reception by the Parish in the adjoining Hopping Procession Visitor Centre. Here the connection between Carlow and Echternach were on display with the vellum Book of Carlow and Echternach 2017 taking pride of place.

On Tuesday the delegation and Ambassador McDonald met the German pilgrims that had walked approximately sixty kilometers over the previous three days to reach Echternach at 7.30am, just in time for 8am mass in the Basilica. Afterwards the delegation partook in the UNESCO World Heritage Status

Hopping Procession. In the procession the delegation were joined by Her Excellency Fleur Thomas, British Ambassador to Luxembourg, His Excellency Chris Trott, British Ambassador to the Holy See, His Excellency Jean Claude Kugener, Luxembourg Ambassador to the Holy See and Patrick Dondelinger, Luxembourg Ministry of Culture.

Lisa Burke, from Killeshin and former Sky News weather forecaster, hosts a radio show on RTL (Radio Television Luxembourg – the national broadcaster) and she recorded an interview in her studio with Cathaoirleach Dalton, Ambassador McDonald along with others including the British Ambassador to Luxembourg and the British Ambassador to the Holy See.



A Carlow delegation attended the Luxembourg National Day celebrations on June 23rd hosted by her Excellency Florence Ensch. Ambassador of the Grand Duchy of Luxembourg to Ireland in Dublin. A Carlow delegation also attended the Ambassador's hosting the Irish launch of Dr Michel Summer's book, Willibrord between Ireland, Britain and Merovingian Francia (690 – 739). This is a significant publication as it is the first biography of St Willibrord published in English in many decades. On Thursday 7th, the Feast of St Willibrord, the St Willibrord Biennial Lecture was presented by Dr Immo Warntjes, Department of History Trinity College, in St Laserian's Cathedral, Old Leighlin, with coordination by Carlow County Museum.

Heritage Week 2024

National Heritage Week took place from the 17th to the 25th of August with the week coordinated in County Carlow by the Heritage Officer.



On Thursday the Museum presented a lecture by Deb Goodrich, Historian in Residence at the Fort Wallace Museum, Kansas, USA on Leighlinbridge's Captain Myles Keogh. Myles was the Commander of the Fort in its early years and Deb explored his role and contribution. Keogh, as commander, and Frederick Beecher, as adjutant, were responsible for turning the ramshackle structures into a real fort. Keogh established the first library and school in Wallace County on the post. The Fort Wallace Museum honors Captain Keogh each March with the Captain Keogh's Emerald Banquet.

Kevin Barry Portrait

The Museum had conservation works undertaken to the framed portrait of Kevin Barry by Anna Francis Levins. The frame and the canvas were all treated, and a protective glass front was added to the frame by conservators Dr Pat McBride, Paper Conservation Studios, and Kathy Day Carrigan. The portrait was back on display by November, the month in which he was executed in 1920. A Conservation Grant from the Carlow Historical and Archaeological Society contributed significantly to defray the costs of this.

Other Right to Read Activities

- → The LEO Right to Read Primary School Short Story Competition Project was very successful with 22 national schools submitting 449 entries. An awards night was held in November with over 170 people in attendance.
- → The Library Awareness Week for KCETB learners took place in October. Library staff prepared and provided library tours, presentations and an online webinar. 207 learners visited the libraries during the week with 18 groups and their tutors participating.
- → The library service collaborated with LEO in delivering the unique 3 Senses

- programme. This business literacy initiative ran from August to November, concluding with a business networking event and panel discussion. Project partners included CCDP, County Carlow Chamber, Carlow Tourism, Powerhouse Women in Business Network and Carlow Community Enterprise Centres CLG.
- → The Hug Your Book programme ran in July and again in December. This collaboration with KCETB Family Learning supports parents and guardians to develop a range of skills to support their children's reading, writing and talking. It helps support children's language and literacy development as well as their social and emotional needs.

- → The annual Summer Stars reading challenge, the national campaign to encourage children to read over the Summer Holidays launched on 10th June and continued to 31st August, over 600 children registered to take part across the county.
- → Ireland Read's Day took place on Saturday February 24th. This is an annual National Day celebrating reading and to encourage people to take some time out to read a book, magazine, comic etc. Eleven events were organised with 182 attendees.
- → Childrens Book Festival 358 children enjoyed 16 events over the month of October. These included visits from authors Nicola Pierce and Brendan MacDonald, craft workshops and camps and clay monster workshops.

Story Streets

The Department of Children selected Story Streets, devised and developed by Carlow County Library Service, as one of two national pilot programmes supporting disadvantaged families and children. Carlow Libraries are leading on this five-year national pilot and work progressed over the year in collaboration with the LGMA Libraries Development Unit. Following preparatory works the pilot programme was rolled out in Tullow and Blanchardstown libraries in November. This project is supported by the Children's Fund and the aim is to perfect our model, expand gradually to other counties, and eventually mainstream Story Streets as a national programme.

Libraries for all Library Development Plan 2025 - 2029

Work was completed on the development of this five-year plan for the Library Service. An external consultant collected a wide range of data and worked with the library management team to agree priorities and strategic objectives for the future of the service. The plan aims to ensure that our libraries are multi-purpose social and educational places for all members of the community to enjoy.


Our Digital Offer

ePress

In May a new online service was introduced which brought all eNewspaper and eMagazine titles under the Borrowbox umbrella, which has already established itself as one of our most popular resources in the Library Service. Named "ePress" it offers access to over 63,000 titles, including some of the country's best sellers such as the Irish Independent, Hello Magazine and National Geographic, and has been enthusiastically embraced by our members.

Hublets

Public IT services were further developed with the introduction of a new Hublet tablet lending device in Tullow, while the same service in Carlow Central Library was upgraded with a new set of devices.

Short Story Dispenser

In the last quarter of 2024, a new machine was installed in Carlow Library, offering patrons the opportunity of availing of printouts of short stories, poems and sketches. The machine is easily portable and can be brought to locations throughout the county.

Assistive technologies and equipment

Dormant Accounts Funding 2024 enabled us to improve accessibility within our libraries for those with physical disabilities. A total grant of €15,000 was awarded by the DRCD

which was match-funded by Carlow County Council.

- → Height adjustable tables and ergonomic chairs were installed in Carlow Central Library
- → All branches received assistive C Reading Pens which are available to borrow
- → ReadEasy Evolve machines were provided in all branches and in Local Studies. These lightweight and portable devices, that help those who are visually impaired by scanning text and then reading it aloud. These scanners use optical character recognition (OCR) technology to convert printed text, such as from books, documents, or even signs, into a format that can be read aloud.

Sensory Services

An innovative range of Sensory Services was launched in April, aiming to create a more inclusive and welcoming environment for all. The new services include a variety of supports such as sensory equipment available for use within the libraries, a Sensory Backpack lending scheme, and the provision of social stories tailored to each branch. All were designed to enhance the comfort and accessibility of library visits. The service also joined the Hidden Disabilities Sunflower network, with all staff receiving comprehensive training in the scheme.

Come & Play

A series of eight Come and Play Music workshops were held across all library branches between January and June. Art Exhibitions

In Addition to local group of artists "Barrowvalley Art Group" Exhibition in April for the Pan Celtic Festival, another Local Art Group "Chroma" held an exhibition during arts week in June

Age Friendly Library

Library staff attended the National launch of the Age Friendly Library Recognition Programme held on February 16th in Edgeworthstown Library, Longford where Minister Heather Humphries awarded charters to each County Library. The Library was also represented at the Carlow Older

Person's Forum roadshow on February 27th, promoting the supports and services that Carlow County Library make available to older people.

Pan Celtic Festival

As part of the celebrations in April Carlow Library hosted An Art Exhibition by the local Barrow Valley Art Group An evening of entertainment with Carlow Storytellers, Carlow Little Theatre, the Dargan Dancers and guests Gala Hutton and Michael Somers. Celtic Family Storytelling sessions with widely acclaimed storytellers Colin Urwin, Aideen McBride, Deirdre O'Byrne and, from Brittany, Katell Kloareg.

Healthy Ireland At Your Library

The Healthy Ireland at Your Library programme aims to contribute to improving the health, wellbeing and overall quality of life of communities and individuals at all stages. Funding from Healthy Ireland has enhanced health and wellbeing book collections and provided for the events and programming in 2024 including:

Talks: Dr Mary O'Kane – talk based on her book "supporting anxious children in an anxious world" on 18th May and Dr Padraic Gibson – talk based on his book launch of 'When the Bubble Bursts' - a book about depression was held on 27th June.

Dr Padraic Gibson also did a talk in November where he discussed the behavioural challenges in children and adolescents and a talk in December which focused on the art of self-deception. In addition,

Carlow County Library Service collaborated with HSE Primary Care and Child Psychology Services to deliver Parenting Talks, Topics covered included Anxiety Management, Managing Strong Emotions and Managing Low Mood.

- → Staff Participation in the Hello How Are You day in May, a campaign about connection and engaging in open conversations about mental health.
- → Changing Gears: This programme was a

- collaboration between Carlow Library and Age & Opportunity. Running over five weeks, it's aim was to at boost wellbeing and resilience and teach skills to manage transitions in mid to later life.
- → Following the success of last year's Singing for Well-being programme, funding from Healthy Carlow was secured for programming across all branches in 2024. The tutor, Regina Hanley, took the lead in making the group a welcoming, fun and safe space for participants. Library coordinators managed the programme and provided ongoing support throughout the programme.

Culture Night

We celebrated Culture Night on September 20th with a series of events: Carlow Library hosted a lovely evening of music, drama, stories and song. The AHA storytellers performed sharing the culture and folklore of Africa. The Carlow Storytellers then performed their unique mix of songs and stories and were joined by the Dargan School of Irish Dance, Carlow Little Theatre, the Butler Sisters and local author Maria O'Rourke Muinebheag Library hosted a poetry reading and storytelling Tullow Library hosted craft workshops for children with local facilitator Sandy.

Science Week

Science Week took place in November and was a collaboration with Calmast (Centre for the Advancement of Learning of Maths, Science and Technology), funded by Science Foundation Ireland. Carlow Library hosted several events to mark the week including - Art and Craft workshops for children with local artist Jean Robertson, a visit from Dave's Jungle, a lecture on DNA and Fingerprinting with Dr Cas Kramer and two Bricks for Kids workshops

Family Time At Your Library

Events were planned as part of the Carlow - A Festive Family Christmas initiative. Wibbly Wobbly Wendy entertained children and their parents in Muinebheag and Carlow libraries. A series of Family Learning workshops were held across all library branches in collaboration with KCETB.

Families were invited to take part in these reading and craft workshops, each receiving a free book as part of the initiative.

Carlow Library hosted children from Kildavin N.S. in collaboration with Music Generation Carlow in a beautiful Christmas Carol Concert in Carlow Library

Lunchtime in the Library

Our third season of Lunchtime in the Library featured talks by poet Rita Ann Higgins, artist and writer Don Conroy and novelists Aoife Fitzpatrick and Sarah Gilmartin. 85 people attended the sessions, engaging with the speakers and hearing all about what shapes their work.

The Library Totem Project

This was a significant undertaking for the branch in 2024. The project, which was grant-aided, involved Liga Valge, as facilitator, with the expertise and enthusiasm to see the project to completion. Her skill in polymer clay sculpture and her dedication to the work was matched by the participants, including our own Gill, who threw herself into the work with real enthusiasm. The team worked steadily from mid-January to late-March to create the elements, each person working on a piece based on their individual vision, while working towards a collectively themed goal. The resulting artwork was launched officially in May and is prominently displayed in the branch, which has prompted numerous discussions and expressions of praise for the result and the work that went into it.

Culture & Heritage Local Studies and Genealogy

313 visitors attended the Local Studies and Genealogy service in 2024. We also offer a service by email and phone with almost 500 people using the services in total. The Genealogy Service continues to grow comprising visitors from UK, United States, Canada, New Zealand, Australia and Tasmania as well as many local Irish visitors. Researchers consulted a wide variety of source material including newspapers, photographs, maps, Minute Books, journals and Estate Papers. Enquiries were received from students, those researching Carlow

localities and family history, local historians, general researchers and school groups.

Heritage Week

Christopher Power

Carlow Library Service was delighted to support the Heritage Office of Carlow County Council during Heritage Week which took place from August 17th to 25th. Some examples of the events hosted in our libraries included 'Learn about Swifts in County Carlow', by Jaroslaw Majkusiak, Maria O'Rourke did a reading from her book 'Defying the Curse' in Borris Library, 'The Pattern of Irish Slate Roofing' by Sarah-Jane Halpin, 'For the descendants, from the ancestors. Connections through personal archives 'by Louise Kennedy, Archivist, Carlow County Council. August 19th marked a special day in Leighlinbridge to commemorate the 150th anniversary of the Belfast address given by John Tyndall. Carlow County Council and Carlow Tourism marked the occasion with a day of celebration including children's workshops, a guided walk, evening lecture, music and drama.

County Archive

The Carlow County Archive is a resource available to all persons interested in the history of Carlow and its people. Material is accessed by a variety of users from academics, students, school groups, family history researchers and authors. An article on the Archive, written by staff member, Christopher Power was published in Carloviana, 2025 edition.

A conservation assessment of the County Archive was carried out by Paperworks Studio in June. The collection was examined, assessed, and treatment proposals and estimates provided to guide future works.

The following important acquisitions were made during 2024 by the County Archive:

- → Finely executed manuscript Estate map Carlow [Browne Clayton Estate] Part of Kernanstown and Part of Chapelstown and Part of the Townland of Carlow in the County of Carlow, the Estate of Robert Clayton Browne. Copied and enlarged from the Ordnance Survey by Hodges and Smith 1841
- → An extensive and comprehensive File of manuscript documents mostly Signed by the Magistrate and Land Agent in Carlow William Fishbourne. It deals with assaults, wage disputes, stealing potatoes, mule, corn, clothing and cattle. It also deals with public house incidents along with several precepts for court appeals. A most interesting file of legal documents from the period of 1816-1831 in the Carlow area and the workings of a legal mind of that period.
- → Suppliers to Carlow Jail 1830's [Co. Carlow] 1832 -42. Signed Proposals from suppliers for provision to Carlow Jail, Best Dublin soap, best Buttermilk, best new milk, rape oil, linseed oil, sweet oil, drying oil, oatmeal, potatoes, brushes with handles. etc. Some were signed by members of the Board of Governors.
- → Two large Files relating to William
 Fishbourne who died aged 88 in 1855.
 During his life he served as magistrate
 and member of the Grand Jury in Carlow.
 He was an officer in the yeomanry during
 the 1798 Rebellion and assisted in
 suppressing the United Irishmen. Over
 200 documents covering the period 1816
 1850 detailing Peace and Answering
 and Prosecute Recognizances, attempt to
 murder, larceny, assault, housebreaking,
 stolen clothes, trespass, combined with
 another batch of Indentures in which
 Fishbourne had an interest.



Decade of Centenaries Lectures

The Decade of Centenaries programme staged two lectures during 2024:

- → 3 April, at Knockbeg College, a lecture by Philip O'Regan of Skibbereen Historical Society, on "The Life and Times of Gearóid O'Sullivan". O'Sullivan played a prominent role in the War of Independence and served at a teacher in Knockbeg.
- → 14 November, at Carlow Central Library, "Local Government in Carlow", by Dr. Matthew Potter, author of The Municipal Revolution in Ireland.

Both lectures were very well attended.

The Flame of Liberty

The other significant, lasting testament to the creative and artistic work of local people in the Tullow area was also an important part of 2024 in Tullow Library. It is the Flame of Liberty sculpture, which was donated to the library in February by Burnside Autocyl Engineering of Tullow. The 300kg sculpture was moved into place in February and an official launch was organised to take place on the actual anniversary of the date of the Easter Monday rebellion 1916.

This involved a collaboration between Burnside, Carlow County Council Library

Service, the Decade of Centenaries Committee, Music Generation, Flynn Catering Services and others, all of whom worked to ensure that the work and generosity of the creators, owners and custodians of the sculpture were marked in a suitable manner.

The process also inspired an article by Dan Cahill, who had worked as an engineer on the original project, and which appeared in Carloviana 2024.

Launch of Carlow Sugar Factory Book

On Tuesday 19 November the launch took place in The Seven Oaks Hotel of "The Carlow Sugar Factory – the extraordinary story of an Irish industrial icon", written by Christopher Power.

The launch was excellently attended with over 200 patrons filling the ballroom in The Seven Oaks, where they were addressed first of all by author Christopher Power, who outlined the themes, motivation and methodology behind his production of the book. There then followed an address by John Kehoe, former Carlow branch chairman of the IFA, who told those in attendance of the enormous sense of pride that Carlovians did, and should, feel about the industry and innovation that sprung from that once great institution. There then followed a few words from Carlow Co. Co.'s Cathaoirleach, Cllr.



Fergal Browne, who spoke of his childhood memories of the Factory, as well as his dismay at its closure in 2005. The book was then launched by Cllr. Charlie Murphy, Chair of the Carlow Co. Co. Centenaries Committee, which led the publication of the book.

The book was exceptionally well received, and a second print run was undertaken in January 2025.

Launch of "Carlow Writers Respond to the Topic of Civil War

Tuesday 17 December saw the launch of "Civil War: Writers Respond – an anthology" at Carlow Branch Library, and marked the completion of the work carried out by Carlow County Council's Decade of Centenaries Committee, which commenced in 2016.

Authors, poets and playwrights from across Co. Carlow were invited to reflect on the theme of Civil War, and use their own individual expertise to create a short piece of writing – in a variety of formats – to illustrate how this emotive theme can be used as inspiration for their creativity. The resultant publication is a very reflective and thought-provoking body of work that explores the devastating division, sorrow and hope that can be found in such conflicts, both amongst

those that lived through them and the generations that followed.

The book was launched by Cllr. Charlie Murphy, Chair of the Centenary Committee.

Centenarians Medals

The presentation of Centenarians Medals to those people living in Co. Carlow that have reached the age of 100 years continued throughout 2024.

Presentations during the year were held for Bernard Landy and Bridget Meaney (both Tullow); Angela Hickey, Kildavin and Essie Glynn, New Oak Estate.

Climate Action

South Eastern Energy Agency Energy Hub and Clinics

In September Carlow Central Library hosted the launch of the Community Energy Hub. Developed by the South East Energy Agency, a not for profit energy agency based in Kilkenny, providing energy services to all citizens across the southeast of Ireland. In conjunction with POBAL, & Carlow, Kilkenny, Wexford & Waterford Libraries, the South East Energy Agency created the Community Energy Hub to help households, community



groups and businesses to better understand energy efficiency and help streamline grant and funding information for citizens to undertake energy upgrades for their homes, communities and business.

Following the launch Carlow's Library branches hosted four Energy Clinics, staffed by the SEEA, in our Carlow, Bagenalstown and Tullow branches

New Library Service Vehicle

In November 2024 Carlow Library Service upgraded its vehicle to an electric Peugeot ePartner, carrying out its commitment in the Carlow County Council Climate Action Plan to replace its diesel vehicles with more sustainable electric versions. A charging point for same was also installed in the Presentation Place carpark.

Lighting Upgrade

Work was completed on the installation of new lighting in Presentation Building Library HQ. The result is that the Library now has motion sensor LED lights which operate in a more energy efficient manner.

LEAF Pilot Programme

During the summer of 2024 Carlow Libraries joined forces with GIY for the LEAF Project (Literacy and Food Education LEAF @ The Library) which will run until September 2025. LEAF looks at growing as a climate action within the community and supports individuals and communities in their efforts to get growing. LEAF provides resources, information, and activities through the library network, and a number of events

were held in growing centres throughout Carlow to mark its launch. The Project will work through to September 2025, engaging a wide range of community groups from primary schools to GIY collectives.

Climate Action and SDG Week Events

Seed Workshop - During Sustainable Development Goals (SDGs) week (23 to 29 Sept), Dee Sewell, a qualified horticulturalist and County Carlow's new Environmental Awareness Officer, delivered four Seed Workshops throughout our branches in Co. Carlow. During these workshops students and members of the public learned more about seeds and how they fit into to the United Nations SDG targets to create a healthy and thriving planet. During the workshop Dee spoke about the differences between seeds, how to store and sow them, when best to sow, as well as tips on minding seedlings. Our seeds workshop was also a great way to start off the public's involvement in our county's LEAF (Literacy Education and Food) programme.

Schools Workshops - Climate Action Week took place from 14th to 20th October and as part of the SEAI and Carlow Climate Action Week program, a series of workshops were held in the library. These workshops were facilitated by Úna Halpin, Wildways Adventures Ltd. and were based around the theme of energy. Úna is a science and geography expert and spoke to the children about the effects of climate change on their natural surroundings.

Public Consultations Events Organised

Carlow Heritage Forum and County Carlow Heritage Plan (2024-2029)

The members of the Carlow Heritage Forum meet on three occasions in 2024 (February/ May and September 2024). The focus of the attention of the members of the Forum was on the finalisation of the County Carlow Heritage Plan. The draft was edited and send for Environmental Screening in early 2024. The completed draft County Carlow Heritage Plan (2024-2029) was adopted by Carlow County Council in April 2024.

Inaugural County Carlow Heritage Seminar 2024

An action of the County Carlow Heritage Plan (2024-2029) was the hosting of an annual County Carlow Heritage Seminar. The inaugural County Carlow Heritage Seminar took place in the Seven Oaks Hotel in April 2024. The focus of the seminar was to showcase the diversity of successful heritage projects delivered around County Carlow, with an emphasis on community group projects funded under the Heritage Council's Community Heritage Grant Scheme and projects delivered by the Carlow Heritage Office.

Historic Structures Fund 2024

Four Protected Structures in County Carlow received funding for necessary conservation works from the Department of Housing, Local Government and Heritage. The structures were Sherwood Park House, Kilbride; Borris House, Borris; Millford House, Millford and Presentation Buildings (County Carlow Central Library), Tullow Street, Carlow.

Built Heritage Investment Scheme 2024

Three protected structures in County Carlow received funding from the Department of Housing, Local Government and Heritage. The funding ensures private investment in the structures. The structures were The Old Rectory, Killedmond where conservation works were carried out on the loggia and the supports were strengthened. The original sash windows in Rathduff House, Carlow were conserved and conservation works and energy efficiency measures were completed in Lower Ballyellen Lockhouse, Carlow.



Community Monuments Fund 2024

Four Community Monuments projects were delivered in County Calow. The medieval church with its Romanesque doorway of St.Finian in Myshall was conserved through removal of vegetation, repointing and flaunching of walls and conservation of portions of the doorway. Two Conservation Method Statements were prepared for two priority historic churches that require conservation, namely the medieval church in Cloonagoose, Borris and the medieval church at Dunleckney, Muine Bheag. A geophysical survey was carried out within the ground of Carlow College St.Patricks in late 2024 and the results have identified geophysical anomalies that warrant further research.

Launch of the Heritage Audit of the Historic Churches and Graveyards in County Carlow (Phase I)

A Heritage Audit of the Historic Churches and Graveyards in County Carlow (Phase I) was undertaking as an action of the County Carlow Heritage Plan (2024-2029) with funding from the Heritage Council. The audit undertaken by Colm Moriarty (Archaeologist) included a priority listing of conservation needs of the structures. The report was formally launched in December

2024 in the Carlow Town Hall by Cllr. Fergal Browne (Cathaoirleach) along with a private screening of a video on the Heritage of the Carlow Ambulance Service, funded by the Heritage Council and launched by Cllr. Fintan Phelan (Mayor of Carlow).

Community Heritage Grants 2024

The Carlow Heritage Officer supported three successful Community Groups in their applications for and progress of, the Heritage Council funded Community Heritage Projects. The Tinryland Heritage Group compiled the extensive compilation of research produced over several years and secured funding to have it used in the production of Heritage App about Tinryland and environs. The Methodist Church, Athy Road, Carlow received funding for essential conservation of the internal façade of the church structure that was suffering from moisture damage. The Cranavane Holy Well Committee in Kildavin produced a video showing the wide range of history and heritage features in Kildavin and environs, combining narration by actor, Stephen Rea and interviews with community members and professional in the field of heritage.

Heritage Week 2024

Heritage Week is the national celebration of heritage in Ireland. The Heritage Office working with community groups and various Departments in the County Council produced a varied programme of over forty events around the County. The events ranged from lectures, workshops, demonstrations and guided walks for all age groups. The Tinryland Heritage Group organised an extensive public exhibition in the Tinryland Community Hall to showcase the wealth of heritage in Tiryland and environs. The event was well attended and was subsequently received the Heritage Council's County Heritage Week 2024 award.

National Heritage Week Award 2024

County Carlow was delighted to have two community groups shortlisted at the National Heritage Week Awards Ceremony that took place in the Royal Hospital Kilmainham, Dublin on 15 November 2004. The community groups were the Friends of Columbanus Myshall in the award category of Connections, Routes and Networks Award for their event titled 'A Journey of Discovery from Mount Leinster Co. Carlow to Bangor, Co. Down' and St. Mullins Heritage and Tourism Group in the award category of Wild Child Event Award for their event titled 'From Wilderness to Wonderment on Wild Child Day'.

Carlow Heritage Office Projects

The Heritage Officer secured funding from the Heritage Council for four heritage projects in 2024. As actioned in the County Carlow Heritage Plan (2024-2028), the Heritage Office contracted Colm Moriarty (Archaeologist) to produce Phase I of a Heritage Audit of the Historic Churches and Graveyards in County Carlow.

Funding was secured for the development of the Carlow Water Pumps that enabled the consultant work with an oral historian to undertake an oral history project on the memories and stories associated with a selection of water pumps surveyed in 2023.

An audit of the vernacular furniture within a pre-famine cottage near Fennagh, Co. Carlow was undertaken by Dr. Claudia Kinmonth in July 2024. The audit identified and recorded several pieces of vernacular furniture and drew attention to significant internal features in the structure.

Videography was produced to raise awareness of aspects of the Heritage of the Carlow Ambulance Service. The video, included old oral recordings of former and interviews with current personnel, was launched in December 2024.

Creative Carlow's Holy Wells - Life Springs Eternal

The Heritage Office secured funding under Creative Ireland to undertaken a pilot project on the Holy Wells in County Carlow titled Creative Carlow's Holy Wells - Life Springs Eternal. The funding enabled the formation of a project team, consisting of a researcher, counsellor and videographer to do a study of the heritage of six selected Holy Wells in County Carlow and to engage with an intergenerational audience about the significance, meaning and well-being associated with the Holy Wells. The project amalgamated poetry produced about the experience of the project into a short video for general circulation. Presentations were delivered at the PPN Network Expo and the Age Friedly Carlow Expo in the latter part of 2024, which afforded the project team an opportunity do short video recordings of people who had engaged with Holy Wells up to the present day. The project was well received and the intention is to expand the project in future years.



arlow County Council's Motor Tax Department delivers a high standard of service.

The public office is open Monday to Friday from 10am to 12.30pm and the online service is available 24/7 - 365 days per year at www.motortax.ie. and accounts for circa 80% of all transactions.

In 2024 18,856 transactions were processed in the Motor Tax public office to a value of € 2.99 million. In addition, 75,638 transactions were processed online to a value of €10.24 million. Total 94,494 transactions to a value of € 13.23 million.

Introduction

I, Coilín O Reilly, Chief Executive (CE) of Carlow County Council am responsible for the Annual Financial Statement (AFS), prepared by the Director of Finance, in accordance with the accounting code of practice issued by the Minister under section 107 of the Local Government Act, 2001.

I certify that the financial statements Carlow County Council for the year ended **31 December 2024**, are in agreement with the books of account and have been prepared in accordance with the accounting requirements of the Minister of Housing Local Government and Heritage.

The AFS is subject to external audit, by an auditor of the Local Government Audit Service, whose purpose is to form an independent opinion of the accounts and state whether the annual financial statement presents fairly the financial position of the local authority and of its income and expenditure for the period in question, and whether the transactions of the local authority conform with the statutory or other authorisation under which they purport to have been carried out. The AFS reports on the day-to-day activity of Carlow County Council in the form of the Statement of Comprehensive Income & Expenditure, summarised by Division. The Statement of Financial Position outlines the Carlow County Council overall financial position as of the 31st of December 2024.

The *Statement of Comprehensive Income* represents expenditure and income on the day-to-day running of Carlow County Council.

A *Statement of Funds Flow* was introduced as part of AFS 2011. While the guidance of International Accounting Standard 7 Statement of Cash Flows has been followed, the business of local authorities is substantially different to most private sector organisations and therefore some minor changes to the format have been agreed to ensure the data displayed is meaningful and useful within the local government sector.

System of Internal Financial Controls

As CE of Carlow County Council, I acknowledge my responsibility for ensuring that an effective system of internal financial control is maintained and operated by Carlow County Council. This responsibility is exercised in the context of the resources available to Carlow County Council. Also, any system of internal financial control can provide only reasonable and not absolute assurance that assets are safeguarded, transactions authorised and properly recorded, and that material errors or irregularities are either prevented or would be detected in a timely manner. Maintaining the system of internal financial controls is a continuous process and the system and its effectiveness are kept under ongoing review.

Financial control environment

As CE of Carlow County Council, I confirm that a financial control environment containing the following elements is in place:

- → Financial responsibilities have been assigned at management level with corresponding accountability.
- → Reporting arrangements have been established at all levels where responsibility for financial management has been assigned.
- → Formal procedures have been established for reporting significant control failures and ensuring appropriate corrective action.
- → There is an Audit Committee which as part of its work programme regularly review the internal financial control system.
- → Procedures for all key business processes have been documented.
- → There are systems in place to safeguard the assets.

Administrative Controls and Management Reporting

As CE of Carlow County Council, I confirm that a framework of administrative procedures and regular management reporting is in place including segregation of duties and a system of delegation and accountability and, in particular, that:

- → procedures for key business processes have been documented.
- → there are systems aimed at ensuring the security of the ICT systems.
- → there are systems in place to safeguard the assets of the local authority and
- → there are appropriate capital investment control guidelines and formal project management disciplines in operation.

Procurement compliance

Carlow County Council ensures that there is an appropriate and ongoing focus on good practice in tendering and purchasing and that procedures are in place to ensure compliance with all relevant procurement guidelines.

Internal audit and Audit Committee

As CE, I can confirm that Carlow County Council has an internal audit function with appropriately trained personnel, which operates in accordance with a written charter. Its work is informed by analysis of the financial risks to which Carlow County Council is exposed and its annual internal audit plans are based on this analysis. I am satisfied that there are procedures in place to ensure that the reports of the internal audit function are followed up.

I can confirm that Carlow County Council has an effective audit committee which carries out an annual effectiveness review of their activities. I can also confirm that an Audit Committee is in place in accordance with the requirements of Section 122 of the Local Government Act 2001 (as amended).

The statutory functions of audit committees as set out in section 59 and 60 of the Local Government Reform Act 2014 are as follows:

I. to review financial and budgetary reporting practices and procedures within the local authority that has established it.

- II. to foster the development of best practice in the performance by the local authority of its internal audit function.
- III. to review any audited financial statement, auditor's report, or auditor's special report in relation to the local authority and assess any actions taken within that authority by its chief executive in response to such a statement or report and to report to that authority on its findings.
- IV. to assess and promote efficiency and value for money with respect to the local authority's performance of its functions; and
- V. to review systems that are operated by the local authority for the management of risks.

I recognise that the audit committee plays a crucial role in the governance framework of local authorities, particularly in the context of increased public sector accountability.

They have an independent role in advising the Council on financial reporting processes, internal control, risk management and audit matters as part of the systematic review of the control environment and governance procedures of the local authority.

I acknowledge the Audit Committee's role in the risk management process and in the continuing review of the control environment and governance procedures in Carlow County Council.

Risk and control framework

Carlow County Council has implemented a risk management system which identifies and reports key risks and the management actions being taken to address and, to the extent possible, mitigate those risks.

A corporate risk register is in place which identifies the key risks and evaluates and grades them according to their significance. The register is reviewed and updated by the Management Team on a regular basis. There is also a risk register in place for each service division and these are also reviewed and updated on a regular basis.

The outcome of these assessments is used to plan and allocate resources to ensure risks are managed to an acceptable level. The risk register details the controls and actions needed to mitigate risks and responsibilities for the operation of controls are assigned to specific staff.

As Chief Executive, I confirm that key risks and related controls have been identified and processes have been put in place to monitor the operation of those key controls and report any identified deficiencies.

The Statement of Internal Financial Control will be included in the draft Annual Report submitted to Council members by 30 April 2025 and thereafter included in the published Annual Report prepared and adopted by the Council by 30 June 2025.

Governance Statement

Purpose

The purpose of this governance statement is to provide relevant information on the governance structures and governance arrangements within the local authority including on council, committees, senior management and related areas. It demonstrates our commitment to effective governance, recognises key legislative and good governance requirements and affirms the Council's compliance with the Local Government Code of Governance obligations.

Good Governance

Fundamentally, good governance in the local government sector and wider public sector is about delivering priorities, achieving objectives, behaving with integrity and acting in the public interest, in ways that are consistent with legal, regulatory and government policy obligations. Governance refers to the framework of rules, relationships, systems and processes by which the local authority is directed, controlled and held to account and whereby authority within an organisation is exercised and maintained. It encompasses authority, accountability, stewardship and leadership, direction and control.

Good Governance Principles

- → **CORE PRINCIPLE 1** Good governance means focusing on the purpose of the authority, on outcomes that deliver sustainable economic, community and wider societal benefits and on implementing a vision for the local authority.
- → **CORE PRINCIPLE 2** Good governance means promoting and demonstrating public service values through upholding high standards of conduct and behaviour.
- → **CORE PRINCIPLE 3** Good governance means members and officials working together to achieve a common purpose within a framework of clearly defined functions and roles.
- → **CORE PRINCIPLE 4** Good governance means developing the organisational capacity and the leadership capability and competencies of members and officials to operate effectively and fulfil the purpose of the organization.
- → **CORE PRINCIPLE 5** Good governance means taking well-informed and transparent decisions and managing risks and performance.
- → **CORE PRINCIPLE 6** Good governance means engaging openly and comprehensively with local people, citizens and other stakeholders to ensure robust public accountability.
- → **CORE PRINCIPLE 7** Good governance means actively contributing to the furtherance and achievement of the Sustainable Development Goals by delivering on the priorities and actions within the Climate Action Plan and the provisions of the Climate Act.

Our Commitment to Good Governance

As the Cathaoirleach/Mayor and Chief Executive of the council, and on behalf of the elected members, management and staff we confirm that;

- 1. We have adopted the governance principles as the fundamental bedrock and philosophy on how we operate as a governing body and as an executive.
- 2. The Local Government Code of Governance has been adopted and the extent to which the Council is in compliance with the Code has been reviewed and assessed.
- 3. The Statement of Internal Financial Control is submitted by the Chief Executive to the Elected Members and to the Audit Committee. The Audit Committee reviews the SIFC and provides an assurance on an annual basis to the Elected Members. Mechanisms are available to the Audit Committee to notify the Elected Members of any issues that arise outside of the normal annual reporting.
- 4. Compliance with legal and regulatory obligations are acknowledged and adhered to.
- 5. There is clarity of roles and responsibilities based on the reserved and executive functions and based on committee terms of reference.
- 6. Codes of Conduct and ethics declarations for members and employees are in place.
- 7. Procedures are in place for the making of protected disclosures in accordance with section 21(1) of the Protected Disclosures Act 2014 and confirmation that the annual report required under section 22(1) of the Act has been published.
- 8. The Council and Committees review their own performance on a periodic basis.
- 9. We have instituted appropriate governance oversight arrangements in respect of subsidiary, associated and related companies.
- 10. As part of our commitment to effective oversight and accountability, we have developed and continue to enhance our overall assurance framework utilising external and internal assurance sources to ensure good performance as part of our governance culture.



The Council's role in relation to migrants and new communities is reflected in the Corporate Plan and Carlow's Migrant Integration Strategy 2020


