Section 1 - Instructions to Tenderers

- 1) Tenderers must read these Instructions to Tenderers prior to submitting tender.
- 2) Tender catalogue can be found on the Carlow County Council website www.carlow.ie or at Reception, County Buildings, Athy Road, Carlow during Opening hours. An “Open Day” will be facilitated for viewing of the roller at Carlow Municipal District depot at Kernanstown Ind Est, Hacketstown Road, Carlow, R93 X798 on a date to be agreed, between 8:30 a.m. and 3:30 p.m. Please contact cmadden@carlowcoco.ie or the Carlow Municipal District office at 059 9136272 to arrange a viewing time.
- 3) With regard to insertion of “Company Name” on each tender page, Carlow County Council will accept a company stamp with authorised signature. For non-companies or individuals please print name clearly in this section along with accompanying signature. Please ensure that the date, address and offer in Euros are all completed in full. Only a completed Lot Item Sheet needs to be returned along with completed Section 3 Form of Tender in a sealed envelope marked “2026 Tender for Sale of Multi-Wheel Rubber-Tyred Roller” and submitted to the “Corporate Services Section, Carlow County Council, Athy Road, Carlow” no later than 12noon on 13th May 2026.
- 4) The Multi-Wheel Rubber-Tyred Roller is “sold as seen”. Any price offered or accepted is to be in respect of the Lot in its present state – the Council will not carry out any further work on the Lot nor will the Council provide any assistance in lifting loading or transporting the Lot once same has been purchased.
- 5) The accepted tenderer will be notified of award of tender by letter for the Lot and the Lot must be collected by the Tenderer within 10 working days of receipt of same.
- 6) Method of payment - Payment as per accepted tender price must be made to Carlow County Council at the Motor Tax Cash Office, and receipt of payment presented to the Carlow Municipal District depot at Kernanstown Ind Est, Hacketstown Road, Carlow, R93 X798 at agreed collection time. Cheques should be made payable to Carlow County Council.
- 7) Collection of sold Lot – Arrangements for collection (including lifting, loading and transporting of Lot) will be the sole responsibility of the tenderer – arrangements for access to Carlow Municipal District depot at Kernanstown Ind Est, Hacketstown

Road, Carlow, R93 X798 to collect Lot items will be set out in the award of tender letter.

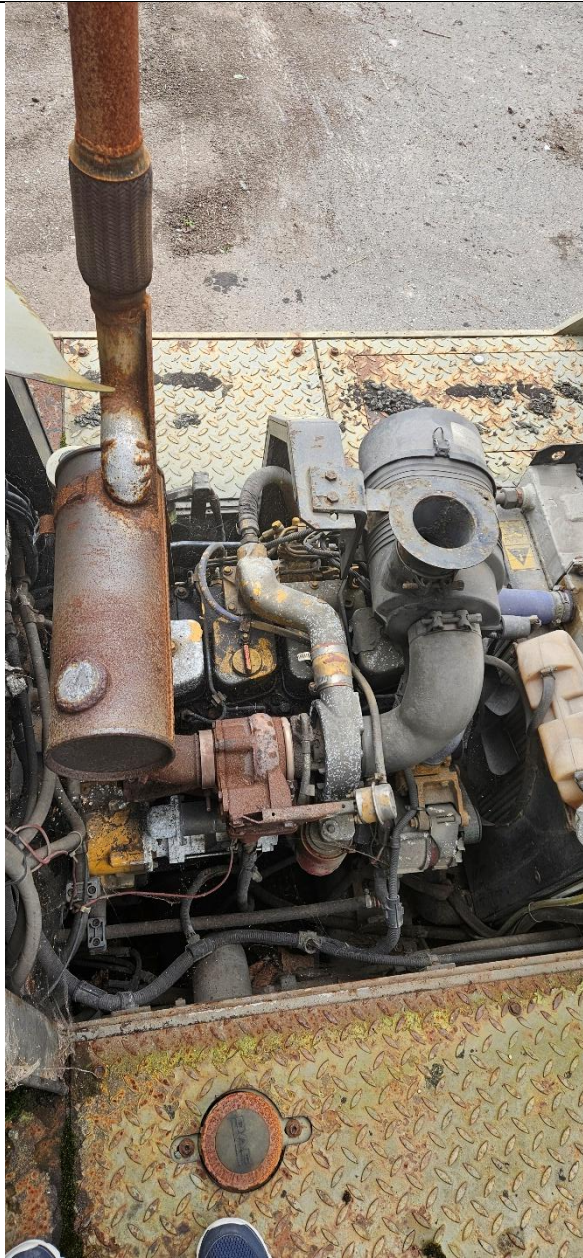
- 8) Insurance – Successful tenderers must provide proof of insurance cover for any vehicle/plant used to collect Lot items from the Carlow Municipal District depot at Kernanstown Ind Est, Hacketstown Road, Carlow, R93 X798.
- 9) Tender assessment process – tenders will be assessed on a price only basis. The highest price submitted for the Lot item will be deemed as the successful tenderer for said Lot item, on the condition that the tender is valid.
- 10) Carlow County Council reserves the right to refuse any or all offers per Lot item without explanation or clarification.
- 11) All prices will be submitted in EURO and payable in EURO – VAT will not be charged on any items.
- 12) Award of tender – Formal acceptance of tender will be issued to successful tenderer for each Lot item. Acceptance of any and all tenders will be subject to Chief Executive Order approval.
- 13) The Council reserves the right to offer any Lot items not collected within 10 working days of the successful notice being posted to the next highest successful tenderer.
