"That this council supports local authority water workers in their demands for the need for a Water Referendum now and a vote within their union on the new Service Level Agreement (SLA) with Irish Water, to start in January 2023.

As such this council will write to the Taoiseach to call for a referendum on the ownership of our water services and call for the following wording be used in said referendum:

'The Government shall be collectively responsible for the protection, management and maintenance of the public water system. The Government shall ensure in the public interest that this resource remains in public ownership and management.'
