"This Council notes that the government set an annual target of 70,000 retrofits to a B2 rating but have only achieved 28,800 under the National Residential Retrofit Plan and that there is an average of a two year wait for households applying for the Better Energy Warmer Homes Scheme. As such this Council will write to An Taoiseach, Minister Eamonn Ryan, and Minister Malcolm Noonan to urge that the Government's National Retrofitting Plan is revised to ensure it is accessible for people on lower incomes and delivered in a timely fashion with consideration to the climate emergency we are in.

In addition, this Council will ask the department to introduce schemes to allow private homeowners to opt-in to retrofitting when social housing in their area is being upgraded. This could save time and money and help meet ambitious retrofitting targets."
