2.1 Audit Committee – Section 60 Report to Council on 2021 Statutory Audit Report

The Report from the Audit Committee was discussed in detail. It was noted that the local government auditor who conducted the audit attended at a meeting of the Audit Committee on 14th December 2022 and provided further clarifications on the report findings and the overall audit opinion. Based on its deliberations, the committee considered that the following area(s) be brought to the attention of the Council.

3.4 – Registration of Fixed Assets

The committee noted that a substantial number of historic housing assets have not yet been registered with the Property Registration Authority. While some progress in registering these housing assets was made during 2022, it is important that the registration process is completed as soon as possible. The committee was informed by the Interim Chief Executive that due to staff resourcing issues the process was delayed but will be addressed as a priority in early 2023.

11.2 – Carlow Arts Centre Ltd

The committee noted that the annual subvention from Carlow County Council to Carlow Arts Centre Ltd had increased from € 498k in 2021 to € 584k in 2022 and to € 650k in 2023. While the committee noted the challenging operating environment post Covid and the exceptional increase in energy costs, the committee requested that the company explore and vigorously pursue alternate funding streams to reduce its dependency on the annual subvention. The committee was informed by the Interim Chief Executive that the company is reviewing its operations which includes evaluating potential income streams and outlined enhanced governance arrangements which are now in place.

Questions raised by the members were answered by Pat Delaney.

This has very serious impacts on our learner drivers varying from additional cost of insurance due to being on a Learner's Permit to inability to take up employment due to lack of Full Driver's License. This motion calls on the Department to give approval for the employment of additional Driving Testers and a review of the operating hours so that more tests could be carried out on the weekend or in the evenings to help alleviate the backlog."
