The Chief Executive advised that a public consultation process in relation to the Draft Scheme is required to be undertaken in accordance with the SPC guidelines.

Following a show of hands it was unanimously resolved:-

Carlow as recommended in the Chief Executive's Report and in accordance with Part 8 Article 81 of the Planning and Development Regulations, 2001 (as amended), the Planning and Development Acts, 2000 (as amended) and Section 138 of the Local Government Act, 2001 (as amended).

### 4. CORPORATE, PLANNING, ECOMOMIC DEVELOPMENT AND HEALTH AND SAFETY

#### (a) Agriculture

Members expressed concerns over invasive plant species such as hogweed and Japanese knotweed identified in various parts of the county.

- D. McInerney advised that a register of complaints of incidents of invasive species is being maintained and it is hoped that a handbook will be available in September on invasive species and how to treat them.
- D. McInerney also referred to problem of crayfish on the river Burrin. The members also queried appropriate time to carry out hedgecutting and the cutting of grass margins along the River Barrow.
- Councillor Doran requested that hedges be cut in advance of schools reopening in September as bus drivers have difficulty operating bus routes due to overgrown hedges.
- D. McInerney advised that the issue of cutting grass margins along the river Barrow was raised at Muinebheag Municipal District meeting. The issue is to be raised with Waterways Ireland.

Members expressed serious concern for the Irish Beef Industry if the EU agreement with Mercosur goes ahead with beef as well as poultry and pig meat being imported as part of a trade deal. Members said the Irish Beef Industry would be wiped out in the event of a no-deal Brexit. Councillor Cassin proposed and it was seconded by Councillor Kinsella that the Council write to the Minister for Agriculture expressing Members concerns and suggesting that the Minister meet with a deputation from Carlow to address their concerns.

### (b) Conference Attendance Approvals

Following a show of hands it was unanimously resolved:-

#### 5. CHIEF EXECUTIVE REPORT

Members considered Chief Executive Monthly Management Report for the period to 30<sup>th</sup> June 2019.

Councillor Browne raised issue of blanket ban on development on regional roads and urged that this policy be amended to remove this blanket ban to allow for discretion where individual applications could be considered. Councillor Browne requested a report for the September meeting of Council on clarification of blanket ban on development.

Councillor C. Murphy also referred to one off housing issues on the N/80, N/81 and expressed concern in relation to the role of Transport Infrastructure Ireland (TII) in planning permissions and queried the requirement to refer applications to TII.

Ms F. O'Neill advised of policy in County Development Plan based on National Guidelines. She will examine the issue of TII planning referrals and revert to the Members.

Councillor Phelan welcomed the successful appeal by Carlow County Council under the Better Energy Communities grant scheme for the replacement of a further 678 public lights by low energy high-efficient LED lanterns.

Councillor Quinn queried commencement date for Local Development Plan for Borris. Ms F. O'Neill advised of tenders sought as part of the review of County Carlow Development Plan in relation to requirement for SEA Screening report and associated Environmental reports. Ms O'Neill advised that the Carlow County Development Plan is due for review December 2019 with the review suspended where it is in progress until not later than 13 weeks after the relevant Regional Spatial and Economic Strategy is made.

Councillor Doran queried if there has been an update on the Barrow Blueway proposals.

Councillor Wallace queried the number of Compulsory Purchase Orders on properties and if there was room for improvement and queried the number of vacant properties in Carlow referring to the number indicated by the Central Statistics Office. The Chief Executive advised that following extensive research by larger local authorities there were major differences in the visual survey and the desk top survey. M. Brennan advised of 457 vacant properties in County Carlow that can be pursued under derelict sites legislation. This figure is based on an exercise carried out by Carlow County Council to determine the number of vacant properties. Councillor Wallace requested a copy of the statistics report.

Ms J. Kavanagh, Housing Officer advised that a comprehensive report on vacant properties will be prepared for the September meeting of Council. M. Brennan advised that properties on Barrack Street are being looked at as an early exercise as part of a Master Plan.

Councillors Dalton and Cassin expressed their dissatisfaction with Carlow not being designated as a rent pressure zone. The Graiguecullen – Portarlington Electoral area has been included and will see yearly rent increases capped at 4%. M. Brennan, acting Director of Housing, outlined the criteria to be designated as a rent pressure zone. Councillor Cassin requested that a copy of the criteria be circulated to the members.

Councillor Dalton referred to the 18 people who recently presented homeless and to the crisis in the rental market with HAP payments not meeting rent demands.

Ms J. Kavanagh, Housing Officer spoke of the varying reasons for homelessness and of the Council working closely with Focus Ireland to put the necessary supports in place.

Councillor Gladney welcomed funding for Bagenalstown Fire Station. D. McInerney advised that following discussions with the Department the available funding is for refurbishment of the station.

Councillor C. Murphy queried update on site at Ardattin. M. Brennan advised that proposals for the site are currently being examined.

Councillor Phelan queried time frame for completion of watermain works on Dublin Street as the works are causing major disruption. D.

McInerney advised that it is expected that works will be completed within the timeframe given.

Councillor Paton expressed his frustration at the slow process of works at Tullow Footbridge. D. McInerney advised that the completion of the works is imminent.

Councillor Paton queried the removal of a small statute, that stood outside the Bridge Hotel in Tullow, and has not been replaced following the works.

Councillor Browne queried update on courthouse railings.

Councillor O'Donoghue queried removal of traffic lights from the square Tullow. D. McInerney to raise issue with the Area Engineer.

Councillor Cassin raised issue of on-going dumping at Springdale, Carlow and queried the disposal of piece of land. D. McInerney advised that the dumping is a localised issue and of carrying out door to door inspections. He advised that to dispose of piece of land would hinder the future access to Askea drain.

#### 6 a. CORRESPONDENCE

Member noted correspondence from Lobbying.ie in relation to information regarding the legislation and further guidance on the Lobbying Act 2015 and Transparency Code.

SPC is to adopt Transparency Code.

- (b) Members supported Notice of Motion from Carrickmacross-Castleblaney Municipal District. Rates and Rateable Valuation causing serious problems for business owners and is not an appropriate way to raise revenue for local government.
- (c) Members noted correspondence from the Office of the Minister for Education and Skills in response to Member's letter in relation to the provision for children with autism in Carlow.

Members expressed dissatisfaction with the response from the Minister's Office and requested that Carlow County Council again write to the Minister requesting a pro-active approach as there is a clear need as demand for support units has risen in Carlow. Also, the need for ASD classes in Tullow was raised as children must be brought to neighbouring schools to avail of special educational needs.

(d) Members noted acknowledgement from TUSLA regarding the issue of a Women's Refuge in Carlow.

Councillors Wallace and Murnane queried reason why TUSLA report could not be made available to members. The Chief Executive advised that the report is a Draft Report and could not be released.

The Chief Executive further advised that the role of the Council is to support obtaining Capital Funding. The Council can work with Approved Housing Bodies to acquire capital funding, but operational funding is required from Tusla to support the Refuge. Members requested that this issue continue to be pursued with the relevant bodies.

Councillor Wallace suggested that the old Bank of Ireland building be considered as a suitable location for a Women's Refuge.

(e) Members noted correspondence from the Office of the Minister for Housing Planning and Local Government in response to Members' letter regarding homelessness.

- (f) Members noted resolution adopted by the members of Clare County Council about the danger of 5G.
- (g) Members noted resolution adopted by the members of Clare County Council for the roll out of free folic acid for women of childbearing age.

Councillor Browne raised issue of Kelvin Grove suggesting CPO of the property and requested that an update on Kelvin Grove be brought to the September meeting of Council.

The Chief Executive advised that her understanding is that Kelvin Grove may be developed as a centre for The Holy Angels and that any surplus land would leave little room for development.

#### 7. NOTICES OF MOTION

Standing in the name of Cllr. John Cassin

"Following a presentation from MSD John Cassin calls on Carlow County Council to complete the footpath/cyclepath out to MSD and give a time frame for the same."

D. McInerney advised that the issue will be examined in the context of Budget planning and timeline and will revert to Members.

#### Standing in the name of Cllr. John Cassin

A discussion took place on the following Notice of Motion and Following a show of hands it was resolved:-

"That we, the Members of Carlow County Council, hereby approve that Carlow County Council again calls on the Irish government to review the rent pressure zones as a matter urgency and include Carlow"

The following Notice of Motion was discussed and noted.

"That we, the Members of Carlow County Council, hereby calls on Carlow County Council to host a major housing conference with Carlow Councillors, Housing Bodies, Department Officials, Council Officials, Construction Federation Officials and any other interested bodies. Carlow needs more social and affordable housing. I welcome all the great work done to date by our own housing section. We are still in the midst of a housing crisis here in Carlow and I want the same efforts put into Carlow as has been put into solving it in Dublin."

Standing in the names of Cllrs. Fergal Browne and John Murphy

"That Carlow County Council ensure that the following is in place at Duckettsgrove for summer 2019; tea and coffee facilities every weekend and public holiday, open access to castle and the excellent garden facilities are maintained and further developed to current high standard and hedging on approach road to Duckettsgrove be cut back to make safer for road users."

M. Brennan advised that due to Health and Safety reasons access to the castle cannot be permitted. Tea and coffee facilities will be provided at weekends and a tour guide will be available.

Members requested a briefing and update on strategy for Ducketts Grove. The Chief Executive advised that a workshop will be arranged for September and that Failte Ireland Funding may be considered.

#### Standing in the name of Cllr. Adrienne Wallace

Members welcomed the Notice of Motion and a discussion took place on Carlow's Climate Change Strategy.

# Proposed by Councillor A. Wallace Seconded by Councillor M. Doran

Following a show of hands it was unanimously resolved:-

"That we, the Members of Carlow County Council, hereby approve that this Council declares a climate emergency.

Following Central governments declaration of a climate emergency we call on the government to immediately take the radical measures necessary to drastically and sustainably reduce our carbon emissions. That all future policies and possible solutions are in keeping with a just transition, and that this just transition is taken within a global context.

We further call on central government to take all steps needed to profoundly reduce our contribution to anthropogenic climate change, and to aid the international effort of preventing irreversible global warming and climate catastrophe."

### Standing in the name of Cllr. Adrienne Wallace

"Carlow County Council calls on the Minister for Health Simon Harris T.D, to introduce as soon as is possible "safe access zones" around healthcare facilities that are providing for the termination of pregnancies.

Carlow County Council believes that "safe access zones" are necessary to protect women against unnecessary distress and anxiety, and indeed harassment, intimidation and bullying when accessing what is a lawful medical service.

Carlow County Council acknowledges and respects the right of a citizen to engage in peaceful protest but believes that those engaging in anti-abortion protests in and around healthcare facilities are not engaged in legitimate public protest but rather they are targeting service users and healthcare professionals".

A discussion took place on this Notice of Motion with some Members expressing reservations as to the wording of the Notice of Motion. Following discussion it was proposed by Councillor B. O'Donoghue and seconded by Councillor F. Browne that the Notice of Motion be amended to read as follows:-

"Carlow County Council calls on the Minister for Health Simon Harris T.D, to introduce as soon as is possible "safe access zones" around all healthcare facilities.
