<u>Housing Crisis</u> Cllr. A. Wallace wished to hold an emergency motion as follows: "That Carlow County Council write to the Taoiseach and the Housing Minister to call for a ban on evictions into homelessness."

Proposed by Councillor: Cllr. A. Wallace **Seconded by Councillor:** Cllr. J. Cassin.

E. Brophy, Senior Executive Officer and chairperson Brian O' Donoghue notified the members that an emergency "notice of motion could only be considered for the purpose of dealing with urgent business and related to a function of the Local authority, or a matter of urgent public interest, subject to the requirement that not less than nine members vote in favour of the matter being considered. It is also a requirement that when the motion is put that not less than nine members vote in favour and the motion must be passed.

The proposer of a motion not listed in the agenda and not in common form, shall, upon moving same, deliver a copy to the Chair and to each elected member"

Cllr A. Wallace delivered a copy of the motion to the chair and to each member and stated the matter was of urgent public interest. It was agreed to hold a vote to establish if nine members or more were in favour of the motion being proposed.

A vote took place and less than nine members voted in favour and emergency motion was defeated and accordingly was not permitted to be moved.

6.0 Notices of Motion/Fógraí Rúin

6.1 Standing in the name of Cllr. Adrienne Wallace

"This motion is to seek the introduction of a Domestic Violence Liaison Officer within Carlow Councils Housing Department. Women and children experiencing Domestic Violence are often left with no other option other than being forced into Homelessness to seek safety or to endure the suffering at home in order to prevent the family being homeless.

We need more support from Carlow Council to remove the alleged preparator from Carlow Council tenancies and to allow the victims to reside in their own home. This Council supports the review of current legislation to strengthen the powers of social landlords (LA or AHB) to remove tenancy rights from persons with a barring order to allow the safe enjoyment of the home by the victim of DV.

However, the core function and purpose of the DV liaison officer would be to:

Act as a direct link between all DV services in Carlow/Kilkenny and Carlow Council for any housing needs DV clients have in a case management model.

Have a knowledge of and be able to access and escalate emergency cases at the different areas of housing such as allocations, HAP, homeless etc.

Act of an advocate for DV victims/survivors within Carlow Council while having an awareness of places available in Refuges/Safe Accommodation/Emergency accommodation for DV clients in order to support a quicker accommodation response.

Understand the extensive Dynamics of Domestic Violence/Family Violence. Have an unbiased non-judgmental approach when working with clients who have experienced DV and to understand the complexities of DV and risk to children exposed to the same.

To write to the housing minister requesting that the Housing Legislation be amended to strengthen the removal of tenants convicted of Domestic Violence offenses.

To offer support and advice from key stakeholders such as Gardai, Tusla etc to support victims of domestic violence access immediate safe accommodation.

Any staff of Carlow County Council who might have to work with victims of DV should also attend mandatory training on how best to support victims in the most appropriate manner".

Cllr. A. Wallace withdrew the motion for discussion at the meeting due to updated information she received since submission.

6.2 Standing in the name of Cllr. William Paton

Following a show of hands, it was unanimously resolved that:

"That Carlow County Council take the single public light at Monastery Court, Tullow in charge and organise its repair as soon as possible." Mr. E. Brophy and Mr. P. O' Gorman advised of the policy of not taking in charge public lights in estates in which the other services are not ready to be taken in charge. Members were advised that if the motion was passed, the light in question would not be repaired.
