Aidan Farrell from Transport Infrastructure Ireland advised that, if approved, tender documents will issue in two weeks with works commencing in twelve weeks. The works to be undertaken at night time will be specified in the tender documents.

3. CORPORATE, PLANNING, ECOMOMIC DEVELOPMENT AND HEALTH AND SAFETY

(a) Carlow Town Development Forum

Members had for consideration Carlow Town Development Forum 2018-2020 Terms of Reference.

The Carlow Town Development Forum is being established to oversee and direct the implementation of a Town Centre Action Plan. The report set out the composition and responsibilities of the Carlow Town Development Forum.

Councillor Phelan sought clarification on the role of the Carlow Town Development Forum, queried the role of the elected Members and The Town Centre Co-ordinator.

The Chief Executive advised that the position of Town Centre Coordinator has yet to be filled.

The Chief Executive advised of the role of the Forum and advised that the Town Centre Co-ordinator will feedback the activities of the Town Centre Forum to the elected Members at Municipal District level.

Members expressed disappointment that no elected members form part of the Carlow Town Development Forum. Members also urged that main stakeholders and community form part of the Forum.

Councillors Deane and Phelan urged any member, if he/she so wishes, to become a member of the Forum.

The Chief Executive stated it would be impractical for all eighteen Members to sit on the Forum.

The item was deferred at 3.45pm to facilitate the Annual General Meeting.

The Order of business resumed at 4.30pm.

Councillor Brian O'Donoghue, the newly elected Cathaoirleach, presided in the chair.

On resumption of item 3 (a) Councillor Phelan stated that the Chief Executive had assured him that the Elected Members will not be excluded from decision making of Carlow Town Development Forum. Nominations to the Forum are to be discussed at upcoming Municipal District Meeting.

(b) Service Indicators 2017

Members had for noting Service Indicators for 2017.

(c) Health

Councillor Cassin expressed dissatisfaction with current Mental Health Services in Carlow/Kilkenny. Councillor Cassin requested that the Council again write to the Minister for Health requesting that the issue be addressed as a matter of urgency. Councillor Cassin also suggested a delegation to the Dáil to highlight the issue.

Members concurred with Councillor Cassin on lack of adequate mental health services and called for more localised services.

Councillor Paton raised issue of Primary Care Centre, Tullow. Councillor McDonald advised that the issue has been raised at Health Forum South Meetings and is at Finance stage with a possible timeline of two years. Members requested a letter issue to the Minister for Health on the issue.

4. CHIEF EXECUTIVE REPORT

Members had Chief Executive Monthly Management Report for the period 1st to 31st May 2018.

Councillor Browne raised issue of Couthouse railings. E. Brophy had circulated correspondence from the Court Service assuring the Elected Members of their commitment to having the railings restored as quickly as possible. Councillor Browne urged the Chief Executive to keep the matter under review and put pressure on the Court Service to complete the works as soon as possible.

Councillor Gladney welcomed the refurbishment of Muinebheag Fire Station.

Councillor Paton congratulated all involved with the housing programme. Councillors Cassin, Murnane and Browne queried update on project for Tullow Road Area and leasing of land.

The Chief Executive advised of series of meetings with the community and state agencies. She advised of ongoing discussions with the Department to secure funding. There is currently no time frame for the project. E. Brophy excused himself from this discussion as a member of the Board of Éire Óg Football Club. Councillors Doran and C. Murphy welcomed €585,000 in funding for Community Involvement Schemes.

Councillor Doran queried update on public lighting upgrade project. D. McInerney advised that a review of public lighting is currently being undertaken and is being done on a regional basis. A report will be prepared for the July meeting of Council on public lighting.

Councillor Quinn raised issue of IPBMI funding for footpaths in the Borris area.

Councillor Browne referred to the huge anomaly in funding for footpaths. Councillor Dalton queried funding for repairs to footpaths in existing housing estates.

All queries raised by the Members were addressed by D. McInerney.

5. CORRESPONDENCE

Members noted correspondence from Limerick City and County Council supporting resolution adopted by Carlow County Council calling on the Minister for Agriculture to consider payment of €200/head for suckler cows.

Members noted correspondence Willie Mullins, Horse Trainer thanking Members for their letter of congratulations.

Members noted correspondence from the Office of the Director General of the Health Service and the Health Service Executive in response to Members letter expressing concerns at the lack of action on the complaint in the Galway Rape Case.

Members noted Notice of Motion from South Dublin County Council expressing solidarity with the Palestinians and the unarmed peaceful protestors who were shot at, with some being murdered by the IDF.

Members noted correspondence from Department of Health and from the Office of the Director General of the Health Service in response to Members correspondence concerning the late cancellation of hospital appointments.

Members noted correspondence from the Office of the Director General of the Health Service in response to Members correspondence regarding the issue of Cervical Smear Scandal. **Members noted Notice of Motion from Waterford City and County Council** welcoming the statutory investigation into Cervical Check and to consider lowering to twenty years to be the age of eligibility for the screening service.

Members noted Notice of Motion from Waterford City and County Council calling on the Minister of Health to request the HSE to review the decision to restrict the use of versatis pain relief patches.

Members noted Notice of Motion from Waterford City and County Council calling on the Department of Education and Skills and /or Department of Health to introduce a scheme to provide all teachers & Special Needs Assistants (who are physically able) with Occupational First Aid training, encompassing CPR.

Members noted Notice of Motion from Waterford City and County Council calling on the Minister of Health to include those that are not children or Young Adults in the provision by the HSE of Free Style Libre to sufferers of Type 1 Diabetes.

Members noted correspondence from Senator Jennifer Murnane-O'Connor re Summerfest, Oakpark, Carlow.

McInerney advised that the existing bridge is listed as a protected structure in the Carlow County Development Plan and recorded on the National Inventory of Architectural Heritage Register with National Importance. Following a show of hands it was unanimously resolved:-'That we, the Members of Carlow County Council call on Carlow County Council to start the process of engagement with Kilkenny County Council to install a pedestrian bridge across the River Barrow at Tinnahinch in south Carlow as the existing bridge has no footpath on either side due to the bridge being so narrow."

The Notice of Motion to be forwarded to Kilkenny County Council.

Councillor McDonald raised issue of Kilcarrig Bridge being a health and safety hazard.

Following a show of hands it was unanimously resolved:-

'That we, the Members of Carlow County Council approve the need for support from Carlow County Council with regard to taxi insurance. Taxis in Carlow are finding it increasingly difficult to obtain insurance and I am asking Carlow County Council to write to the Minister requesting that there should be some help and support in providing this vital service to the public."

7. ANY OTHER BUSINESS WITH THE CONSENT OF THE CATHAOIRLEACH

- Councillor Cassin raised issue of old graveyard at Barrow Track overgrown and in need of maintenance.
- Councillor Pender raised issue of dead and emaciated horses at location outside Carlow Town where the owner or the occupier of the land takes no responsibility for the horses.
- Councillor Quinn expressed disappointment that there was no media presence at Bagenalstown Municipal District Meeting and that Meeting and AGM were notified at two different locations.
- Councillors McDonald, Doran and Quinn raised issue of Planning matters, with different interpretation by planners of what is acceptable in terms of the County Development Plan and lack of clear guidelines. The Cathaoirleach proposed a workshop with Planners and Members.
- Councillor Murnane raised issue of response from the DPP to Members' correspondence on the sentencing in the Galway Rape Crisis case.

This concluded the business of the meeting.
