### 4.0 Chief Executives Report/Tuarascáil an Phríomhfheidhmeannaigh The Chief Executives Report was discussed in detail. Questions raised by

The Chief Executives Report was discussed in detail. Questions raised by the members included progressing of housing in Ardattin due to positive engagement with Irish Water, broadband issue with use of copper cable, delays with Irish Water in progressing Ballinabranna housing and reinstatement of roads following works on footpaths/roads.

The Interim Chief Executive and Directors of Services answered questions raised by the members.

#### 5.0 Correspondence/Comhfhreagras

Members noted response from RSA in relation to waiting times for driving tests in County Carlow.

Members noted correspondence from Kerry County Council calling for the award of medals as recommended by Commandant Pat Quinlan to the veterans of Jadotville.

Members noted correspondence from Sligo County Council querying why Sligo and North-West has not been included as a surgical hub and asking that Sligo University Hospital be added to the list as 6<sup>th</sup> surgical hub catering for people of Sligo, Leitrim, Donegal, North Mayo and North Roscommon.

Members noted correspondence from Sligo County Council calling on the Minister and the Department to address the anomaly that exists under the older and disability grants scheme where retired old age pensioners transfer their homes to the next of kin and amend the terms and conditions of the schemes to exclude the income of the registered owner and their spouse if they do not reside in the property.

Members noted correspondence from Sligo County Council calling for the introduction of legislation at an EU level so that social media accounts are traceable to people operating them which would stop anonymous abuse, online bullying and trolling.

Members noted correspondence from Sligo County Council calling on Minister of Transport to introduce a scheme to make funding available to our regional roads to address realignment and other safety issues.

Members noted correspondence from Cavan County Council calling on Minister for Agriculture, Food and the Marine to intervene and prevent semi-state body Coillte from entering into joint venture arrangements with Gresham House. To review the relationship between Coillte and Gresham House and the proper control of commercial afforestation. Calling on Minister for Agriculture, Food and the Marine and Minister of State to outline that the forestry deal between Coillte and Gresham House and selling Irish lands to an outside fund, is not in the best interest of the people of Ireland.

Members noted correspondence from Westmeath County Council requesting the Finance Minister to design and implement a comprehensive regional public banking system that makes full use of the remaining financial services infrastructure in local towns and other areas in Westmeath to deliver an essential local banking service to local communities and businesses that would augment the work of post offices and credit unions and give local people and business real finance and borrowing options and keep local towns thriving.

Members noted correspondence from Cork County Council asking that the new Planning & Development Bill would take the opportunity to address identified concerns with regard to Ireland's need to meet the requirements of the Aarhus Convention to which it is a signatory

### 6.1 Standing in the name of Clirs. B. O'Donoghue, F. Phelan, J. McDonald and W. Paton

"That it is the policy of Carlow County Council to encourage active travel in our towns and on our roads, with particular focus on the prioritisation of pedestrians and cyclists via segregated routes and shared spaces, where appropriate, in the interest of a safer and healthier Carlow for all public realm and road users"

#### 6.2 Standing in the name of Cllr. Adrienne Wallace

"Noting that last year was the worst year on record for violence against women. Noting the statements by local Government TDs and Ministers that Carlow was due to have a refuge by 2024 this council condemns the recent revelation by Minister Harris in response to a Parliamentary Question that Carlow is not on the list for any refuge spaces in 2024. As such this council will write to the Minister for Justice, The Taoiseach and all local Government TDs calling for urgent action and a commitment that Carlow will have a refuge in place by the end of this year at the latest."

\*\*For Reference, the Parliamentary Question was asked on 16/2/23 by Paul Murphy TD. Minister Harris stated "The Government has agreed to prioritise the delivery of 98 refuge spaces in Sligo, Cavan/Monaghan, Cork City, North Cork, West Cork, Dún Laoghaire-Rathdown, Westmeath, Portlaoise, Balbriggan, Longford, Carlow and Offaly. In the initial phase of this work, we expect to have delivered 24 places in Wexford, Dundalk and Navan in 2024."

#### 6.3 Standing in the name of CIIr. Adrienne Wallace

"That this Council seek legal advice on ensuring the continuation of a Carlow County wide eviction ban in the event the Government fails to extend the national eviction ban".

The Interim Chief Executive advised that the Council does not require legal advice to establish that the Council cannot implement an eviction ban. A discussion took place.

#### 6.4 Standing in the name of Cllr. John McDonald

"Irish Water is not fit for purpose. We know they are causing obstruction to the construction of housing due to lack of water and wastewater infrastructure. In Carlow two projects are delayed because of Irish Water (Ardattin and Ballinabranna). Carlow County Council will write to the Minister of Housing, Local Government & Heritage, requesting Irish Water is returned to the local Authorities control and that Irish Water is not to be privatised."

It was agreed to defer this meeting to the April Council Meeting, in the absence of the Proposer.

#### 6.5 Standing in the name of Cllr. Andy Gladney

I Cllr Andy Gladney ask Carlow County Council to make representations to the Minister of Health with regards to the diminishing number of dentists taking medical cards. A significant number of contracted dentists across the country have withdrawn from the dental treatment service scheme (DTSS). At present most community health care dentists are at full capacity and unable to take on patients. Medical card patients are being dropped by dentists no longer accepting medical card holders and finding it near impossible to find another practice who take medical cards or have the capacity to take them on as a patient. The number of people been treated by the dental treatment service scheme is dropping year on year. There is a lack of primary early dental check ups causing delays in referrals for orthodontic care and early intervention treatments. There is around 13,000 children awaiting orthodontic treatment. Underpayment has led to an exodus of dentists from medical card schemes and leading to massive delays.

I ask we call on this government to take action now. They need to improve access to dental care in an equitable and sustainable manner for all, across all income groups. We need a complete review of the system. We need to support investments in addressing staff shortages right across the dental sector.

We the members of Carlow County Council are asking the Minister of Agriculture to immediately increase the payment on the Sheep Welfare Scheme from €12 per ewe to €30 per ewe. This is in light of the poor price for sheep meat which has persisted for the last couple of years. This will help alleviate some of the financial hardships on sheep farmers.
