# 3.0 Presentation to Commemorate the 100<sup>th</sup> Anniversay of An Garda Síochána

Councillor Fintan Phelan (Cathaoirleach) invited Councillor Michael Doran (JPC Chair) to join him in welcoming both Chief Superintendent Padraig Dunne, and, Superintendent Aidan Brennan to the meeting. Councillor Doran acknowledged the importance of such an occasion.

The Cathaoirleach continued to welcome all in attendance as follows;

"We are joined today by Chief Superintendent Padraig Dunne and Superintendent Aidan Brennan on behalf of An Garda Síochána. Today, as a council, we will make a presentation to An Garda Síochána recognising the centenary of their establishment.

Following the Civil War and the truce of July 1921, the RIC disbanded and a new police force 'the Civic Guard' (renamed Garda Síochána na hÉireann on 8 August 1923) was formed by Michael Collins and the Irish Government.

Dublin Castle, the centre of British Rule in Ireland for nearly 700 years was formally handed over on August 17, 1922 when Commissioner Michael Staines led his new police force through the castle gates.

Since then, members of An Garda Síochána have protected the Irish people and our communities. This represents 100 years of service to our nation. As the lead civic authority, it is fitting that Carlow County Council would mark the centenary of the establishment of the Gardaí. I am delighted that we are joined by Chief Superintendent Dunne and Superintendent Brennan today to accept this presentation.

As Cathaoirleach of this council I thank you and all members of An Garda Síochána for your service to this County, Country and our people".

Councillor F. Phelan then invited Chief Superintendent Padraig Dunne to take the Chair to say a few words. Chief Superintendent Dunne thanked the elected members and colleagues of Carlow County Council for their valued support. He acknowledged the sacrifices made by his colleagues in carrying out their duties, and both he and Superintendent Aidan Brennan, were honoured to accept this presentation on their behalf.

## 2.0 Presentation to Rachel Diyaolu

Councillor Fintan Phelan (Cathaoirleach) welcomed Rachel Diyaolu and her father, Taiwo to the meeting.

The Cathaoirleach continued to welcome all in attendance as follows;

"Elected members and colleagues, I am delighted we are joined today by Rachel Diyaolu and her father Taiwo. You are both very welcome to our Council meeting. Today, as a council, we will make a presentation to Rachel in recognition of her resilience. As we all know, as a result of the Russian invasion of Ukraine, Rachel found herself in a very difficult and dangerous situation whilst studying medicine in Sunmi, Ukraine. Fleeing a war is a situation that she never thought she would find herself in, indeed it is a situation no one should find themselves in.

Through her determination and resilience and with the help of two brave Scots Men, Rachel made her way across the country and thankfully arrived home to her family and our community here in Carlow safely.

Before studying in Ukraine, Rachel represented our County on Carlow Comhairle Na Nóg and was their delegate to National Comhairle Na Nóg. I know the work that she has done on mental health awareness whilst a member of Comhairle has been invaluable to so many young people".

He then invited Rachel to take the Chair to say a few words.

Rachel thanked everyone and was honoured to accept the presentation.
