2.1 Official Launch of Project Carlow 2040

M. Rainey, Director of Service presented this report. Project Carlow 2040 is an ambitious regeneration strategy for Carlow Town with transformational and aspiring ideas for the economic, social and environmental benefit of Carlow. The aim is to enhance the town centre as the heart of Carlow town by providing attractive and accessible public spaces with new pedestrian linkages. A thriving town centre will boost the local economy and community life and attract tourists to the area for the unique architectural, cultural and heritage townscape.

The draft Strategy went on public display from 24th September to 5pm on Monday 26th October 2020 were submission were invited. Consultations also took place with local stakeholders. A total of 26 submission were received and collated into submission report which was considered by the Carlow Municipal District on Monday 2nd November 2020. Amendments to the draft were agreed and members gave their approval for Project Carlow 2040 to be listed for formal approval at the November Council meeting.

Members welcomed this plan and complimented all involved in making the plan and all those who took the time to make submissions. Cllr. F. Phelan advised that a relative of his, who is not a connected party under the Act, owns lands in the Pembroke area, which is in the plan area and that Councillor Phelan would therefore not be commenting on the

plan as it relates to Pembroke and asked that this be noted in the minutes. M. Rainey responded to all questions raised by members.

"I am calling on the Government to ensure that no frontline workers will have to cover the cost of a private Covid 19 test in order to travel home within Ireland to spend time with their families at Christmas if restrictions have been lifted."

5.3 Standing in the name of Cllrs. Adrienne Wallace and John Cassin

"That this council immediately write to the Government to demand that they unseal the files from the Mother and Baby Homes commission. This council should also outline in its correspondence that such a blanket denial of access to personal data undermines the purpose of this Commission, which was to respond to complaints of unlawful interference with private and family life, denial of personal and family identity, and denial of information about loved ones who have disappeared or deceased. Furthermore, this council should note that the Commission's denial of GDPR rights for the past two years does not mean that further denial of them by the Government is justified: it means that rectifying the situation is all the more urgent. This should be dealt with in accordance with the GDPR which provides a plethora of rights giving a person control over how their personal data is used. A copy of this motion should also be sent to every local authority in Ireland, north and south, as correspondence."

- The Mother and Baby Homes represent a very dark part of our State's history.
- That survivors of Mother and Baby Homes have legitimate concerns regarding access to their personal information.

Therefore, the Council will write to the Taoiseach and Minister for Children, Disability, Equality, and Integration requesting the following:

- That the Final Report of the Mother and Baby Homes Commission of Investigation be published as soon as possible and include the details of the experiences of survivors in each institution.
- That the Government provide a full State response to the findings and recommendations of the Final Report.
- That the Government publish new statutory information and tracing legislation without delay.
- That survivors of Mother and Baby Homes are given access to their personal records in a manner consistent with GDPR.
- That the Department of Children and Túsla work with the Office of the DPC to ensure that the rights of survivors to personal information about themselves under data protection legislation and the DGPR are fully respected.
- That the Government urgently put in place a range of supports for survivors and adoptees.
- That the Government continues to engage in consultation with survivors and their representative organisations as they establish a national archive of records related to institutional trauma during the 20th century.
- That a copy of this motion should also be sent to ever local authority in Ireland, north and south, as correspondence. "

This meeting can take place online or in person."
