3.2 First Home Scheme

M. Brennan briefed the meeting on the First Home Scheme. The Scheme was established by the Government in partnership with mortgage lenders to support the purchase of new homes in the private market. M. Brennan advised that this is not a local authority loan, but the Council will publicise it. He advised on eligibility criteria for the scheme and its aim to make home ownership achievable for thousands of individuals and families by bridging the gap for first-time buyers and other eligible homebuyers, between their deposit and mortgage and the price of their new home. It is known as a shared equity scheme whereby homebuyers will enter into a contract with the FHS and receive funds from the Scheme in return for the FHS taking a percentage ownership in the property purchased. The minimum equity share is 2.5% of the

property purchase price, or €10,000, whichever is higher. The property must be a newly built house and be bought as your principal private residence and be within the local authority property price ceiling which is €250,000 in Carlow.

The members raised queries in relation to the lower property price ceiling in Carlow than in other local authorities. M. Brennan stated that this matter had been raised at a meeting held with the Department and they indicated that they would keep this issue under review.

3.3 Tidy Towns Awards 2022

The elected members congratulated Clonegal on County Winner, Clonegal, Carlow Town and Leighlinbridge on Silver Medal award, Ballon on County Commended Award, Leighlinbridge on Highly Commended Award & Climate Action Award, Bagenalstown on Endeavour Award and all the tidy town committees on their increased marks this year. The members commended all the groups for their hard work and also Team Carlow for their Saturday morning litter clean up in Carlow town. They also thanked the Council for their involvement and assistance with the tidy town committees in their endeavours.

Members expressed concern with the difference between marks for national winners and that of the smaller towns and felt that the smaller towns are falling behind and felt points inflation was an issue.

Members raised issue of increased dumping on the country roads and also a big issue in areas near food outlet premises.

3.4 Carlow Southern Relief Road - Preliminary Business Case "Shortlisting of Options" – Update

P. O'Gorman confirmed that the Department of Transport has now approved the undertaking of a competition to engage specialist technical services to progress the required assessments for the proposed Carlow Southern Relief Road Scheme in order to complete the Preliminary Business Case "Shortlisting of Options". He advised that there is a lot of work involved. He expects to have the tender documentation completed in Q 1 next year, Evaluation and Recommendation should take 4-6 months and it would be hoped to have Consultants appointed next year. He briefed of the four shortlisting options to be considered and advised that the preferred route will then be finalised from the preferred option.

Questions from the members were answered by P. O'Gorman.

The Cathaoirleach welcomed Justin Gleeson, People in Place to the meeting. He gave a comprehensive presentation on the Draft Local Economic & Community Plan including timeline of works and the role for Carlow County Council elected members, current Project Works, Socio-Economic Profile, LECP Review and Draft consultation Strategy.
