This delay is having a huge impact on those waiting, who are predominantly young people. This council therefore calls on the appropriate Minister to put in place provisions to reduce the waiting lists of both the driving theory test and driving practical examinations as a matter of urgency. This council also calls for a reduced fee to be put in place for learner drivers who are sitting the driving test after a failed first attempt. A copy of this motion is to be sent to the Minister for Transport and Minister of State with special responsibility for international and road transport and logistics."

To call for an introduction of genuine rent caps, a ban on evictions into homelessness and to streamline CPOs of more vacant homes than outlined in the Government's plan. It should also call for an end to the over-reliance on the private market to provide social housing and instead call for a state construction company to build social and affordable houses."
