Members raised the issue of the My Carlow Plan and requested this matter be listed on the agenda. B. O'Brien advised that the economic development officer and head of Enterprise would attend every meeting if members requested. This was agreed.

# Housing, Community, Recreation & Amenity *Housing Project*

MI. Brennan advised of housing report circulated and advised of the programme for 2019 - 2021. He answered questions from members on various housing issues; including housing projects; tenant liaison officer; vacant houses office; retrofitting of older houses; available land; a woman's refuge; downsizing of tenants voluntarily in areas near where the tenants currently live; assistance to homeless persons; persons in emergency accommodation; persons sleeping in vans; housing for older persons; unfit private sector properties requiring inspection; list of vacant houses; specific plans for Barrack Street and Staplestown Road, derelict sites for CPO; design brief for MyCarlow and Barrack Street, town centre living, obtaining a Túsla report on a woman's refuge; number of rough sleepers.

The Mayor also took Item 6 Notice of Motion at this stage.

"That the Housing Section of Carlow County Council draw up proposals for redevelopment of houses/lands owned by the local authority at Lower Staplestown Road/ Lower Pollerton Road and Barrack Street." This was Proposed by Cllr. F. Browne, Seconded by Cllr. J. Cassin and Agreed following a show of hands.

B. O'Brien replied in relation to Barrack Street and Staplestown Road.

#### Tullow Road Project

M. Brennan briefed the meeting on the report circulated and answered questions from members on the project and the next steps.

It was agreed to provide a list of outstanding fines for environmental issues.

Cllr. Murnane Proposed that the Council would provide a lorry and the members organise a clean up in the area

E. Brophy advised in relation to standing order No. 20 requiring that not less than 6 members vote in favour of a proposal to consider a motion proposed from the floor without notice. A show of hands resulted in seven in favour and the Mayor allowed the motion.

The Mayor took a vote which resulted in 6 in favour of the amended motion.

P. Harrington briefed the meeting on the pay parking in Graiguecullen which is awaiting the delivery of a meter and the erection of poles will be arranged in advance of the signs being delivered.

#### Update Community Involvement Scheme (CIS) Scheme 2019

- P. Harrington answered questions from members on various roads and municipal district issues.

It was agreed to contact to the owners of a car park at Tullow Street to advise of the requirement for better advertising of the risk of clamping, and particularly at night time and the demarcation between the private car park and church users.
