#### 2.1 Part 8 Process – Destination Towns Public Realm

K. Comerford, Head of Local Enterprise Office and Conor Moriarty, Senior Executive Architect presented this report. Carlow County Council propose to upgrade the space between Visual and Carlow College as part of a Destination Towns Project part funded by Failte Ireland. The works include resurfacing, provision of seating, lighting upgrade, signage upgrade, construction of wall (including integrated seating) and associated ground works.

This project is aimed to enhance the visitor experience to Carlow Town and forms part of an overall tourism development investment in Carlow Town supported by Failte Ireland. K. Comerford, C. Moriarty and M. Rainey responded to questions raised by members.
