- that Driver Information Board be changed to 50kph speed limit at the entrance to Bagenalstown Swimming pool,
- to establish if there is an annual maintenance programme for playgrounds in the Municipal District area,
- the need for edges/trenches and road drainage to be checked due to recent broadband works being carried out by Actavo,
- upgrading of lights at the laneway in Kilree to alleviate anti-social behaviour,
- to check the signage on entry to Bilboa
- to check that both lights in the churchyard in Ballinabranna are working
- that consideration be given to improve the safety of pedestrians due to the parking outside the area outside McGrath Hall adjacent to the National School,
- request to see if larnród Éireann had submitted any plans for the community use of the Railway Station Building.
- an update on the status of the mining/prospecting licence in the Tomduff area.
