## 2.0 Business Prescribed by Statute, Standing Orders or Resolutions of the Municipal District Members

#### 2.1 Proposed Part VIII – Volunteer Hub, St. Enda's

That a proposed Part VIII planning application be commenced to develop a Volunteer Hub on Sleaty St, Graiguecullen, Co. Carlow in partnership with Carlow Volunteer Centre.

#### 3.0 Consideration of Reports & Recommendations

#### 3.1 Winter Services Plan 2023-24

Mr. B. Knowles, Senior Executive Engineer, presented the members with the Winter Services Plan 2023-24 for district and answered all queries raised. The members raised a number of issues which included:

- Upgrade of water mains and proposed road closure on R726 from Brownshill Cross to Killerrig Cross.
  - B. Knowles to contact Irish Water who are the main contractors regarding communicating to the residents of the proposed closure.
  - Emergency services access while works are ongoing.
  - The possibility of the works being done during the night to keep the road open during the day.
- Salt boxes to be places in housing estate.
- Hedge cutting To remind landowners of their responsibility, season ending February.
- Motorist to reduce speed in bad weather.
- Road walkers and cyclists to use high visibility clothing.

That the Winter Services Plan 2023-24 as recommended was

The Town Water Relief Programme team were congratulated on the success of the project.

#### 3.2 Carlow MD Engineer's Report

Mr. B. Knowles, Senior Executive Engineer, presented the members with his report for district and answered all queries raised. The members raised a number of issues which included:

- Halloween festive lights on the Town Hall look great and the possibility of a similar plan for Christmas.
- Staplestown Road residents queried if there will be on street parking when works are completed.
- Bridge flyover M9 Ballybar and Hacketstown road weeds.
- Pedestrian crossing on St. Patricks Avenue near the Credit Union.
- Completion of footpath on the Hacketstown road.
- E-bikes request more bike to be made available.
