#### 3. Consideration of Reports and Recommendations

#### 3.1 To consider Part VIII Development – Bagenalstown Cemetery

Pádraig O'Gorman acknowledged that Bagenalstown Cemetery is nearly at full capacity. He advised that engagement has been made with a neighbouring landowner and 'Agreement in Principle' has now been agreed. He welcomed Liam Carroll, Senior Executive Officer, Environment and invited him to make his presentation.

Liam Carroll confirmed that the land most suitable for an extension is to the North-East of the existing cemetery. Municipal District and Environment staff will work in collaboration to prepare design drawings. There is potential for 1,210 plots in total, which will extend the life of this cemetery by 30 to 40 years.

Liam advised that the cemetery design will incorporate a Columbarian wall to cater for the cultural change in Ireland. He confirmed that changes will be required to the entrance while also incorporating approximately 40 car parking spaces. Consideration should also be given to a 'Lawn Cemetery' which is becoming more widespread throughout the country, and is easier to maintain. A decision on this is not necessary now, but it is an idea that will be looked at in the future.

Pádraig O'Gorman answered all queries. He confirmed that approval is required from the Municipal District followed by full Council approval. This is followed by a Public Consultation period of 6 weeks. Plot layouts must be agreed before tender documents can be prepared.

Liam Carroll answered queries. He envisaged works to commence February/March 2026 and will take approximately 6 – 8 weeks.

#### 3.2 Muinebheag Public Realm Project Update

Pádraig O'Gorman confirmed that this project is 90% complete and is expected to be 98-99% complete by Easter. He advised that once the tarmac is finished, there will be an official opening of this fabulous space in May or June. All queries were answered.

## 3.3 Ballyellen Carpark - Update

Lilly Slye gave an update on this project and confirmed that good progress was being made, with expected completion by Easter. All queries were answered.

## (iii) Launch of Blackstairs Art Publication & Exhibition

As part of "Applied Learning Programme for High Nature Value Landscape Communities in the Blackstairs", students from Borris College created artwork inspired by the Blackstairs. Shane Casey, BioDiversity Officer, Carlow County Council extended an invitation to Members to attend the launch of this beautiful publication which will be held on Friday, 11<sup>th</sup> April at 11.00 a.m. in Borris Library.
