3.1 Tullow Town Park/Town and Village Application 2021

Brian O'Donovan presented phase 1 of a plan prepared by Anthony Johns, Landscape Architect for the redevelopment of Tullow Town Park. Phase 1,

valued at €500,000 was submitted to the Department for consideration under the Town and Village Scheme 2021. The new development would include a revised walkway and new playground.

Members welcomed the application and proposal. A request was made to provide a list of all applications under Town and Village Scheme for the Tullow Municipal District.

3.2 - 3.6 Municipal District Roads Report

Pat Harrington, Municipal District Engineer provided Members with a comprehensive report on activities in the Tullow Municipal District Roads Programme. Updates included:-

- Road resurfacing programme and status
- CIS/LIS Update
- Junction Vegetation Control Programme
- Drainage Projects

Members expressed their appreciation for the comprehensive report and the extent of the works completed to date in 2021. Members particularly commented on footpath works in Kildavin and schemes in Redbog and Kilalongford that were recently completed. Pat Harrington noted that the recent hot spell had seen temperatures up to 50oC and that maintenance around this was a priority. Questions were raised regarding:-

- Responsibility for noise pollution
- Water outage notice issued before the meeting
- Externals to houses in Hacketstown
