3. Consideration of Reports and Recommendations

3.1 Graiguenamanagh/Tinnahinch Flood Relief Scheme Update

Joe Scully, Executive Engineer, Kilkenny County Council, Philippie Beubry Senior Executive Engineer, Kilkenny County Council attended with Dr. Sean Harrington of Ayesa Consultants. A presentation including a map of the works was given by Dr. Harrington and the following areas were discussed.

- Overview of the Scheme.
- Areas which will benefit specifically from the Scheme
- Flood control structure
- Ongoing works in Graiguenamanagh

Dr. S. Harrington, J. Scully and P Beubry answered all questions from Councillors.

3.2 Housing Report

Cllr. Daniel Pender congratulated Niall Barrett on his new appointment in Housing Department.

Niall Barrett, SEE Housing Department gave a progress report on Housing in the Muinebheag MD area. The following areas were highlighted.

- Housing development at Ballyknockan and Leighlinbridge allocated
- Housing development at Upper Main Street Borris (2 Units) due to be delivered in Quarter 3 2025
- 17 units in Borris due to be delivered in Quarter 4 2025
- 3 units at Bilboa due to be delivered in Quarter 3 2025
- 1 unit at Ballymurphy still at design/proposal stage. Due to be delivered 2026/2027
- The number of housing stock of Muinebheag MD, along with the housing requirement

All questions raised were answered by both Máiread O'Brien, A.O. Housing and Niall Barrett SEE Housing Department.

3.3 Active Travel Update

Seamus Loughlin, Senior Executive Engineer, Active Travel circulated handouts and gave an update on his Section. The following projects were discussed and the current status was given on each:

- Ballyellen Footpath Scheme – Completed awaiting ESB connection
- Goresbridge Pedestrian Improvement Scheme – New Bicycle Parking installed
- SRTS St. Brigid's National School, Muinebheag - Completed

- SRTS Queen of the Universe NS, Muinebheag – Part 8 stage completed.
- SRTS, Presentation De La Salle, Muinebheag – At proposal stage.

S. Loughlin answered all queries raised by the Councillors.

Lily Slye Senior Executive Engineer Muinebheag MD gave a progress report on current MD projects. The following items were raised:

The process for review of the Bye laws was explained in full and Members were advised that the closing date for receipt of proposals for change and/or new locations is the 30th September, 2025.

3.6 Bagenalstown Cemetery Update

Pádraig O'Gorman Director of Services, gave a brief update on the status of Bagenalstown Cemetery. The Part 8 process was slightly delayed and will commence Tuesday 9th September, 2025.

Barry Knowles, Senior Executive Officer circulated handouts in relation to ORIS and highlighted the following:
