"Carlow Municipal District install an active warning system on Carpenters Way to alert motorists when

the road floods.

While Carlow County Council provides service alerts—including flood warnings—via the MapAlerter system to residents who subscribe, this is a remote digital/phone alert service and not a roadside, physical warning system.

On Carpenters Way significant surface water issues have previously been reported along Carpenters Way in Carlow, highlighting safety risks from flooding.

Physical signage is in place to warn about flooding, but these signs may be hard for motorists to see at night or during poor visibility.

There is currently no dedicated physical system to actively alert motorists on-site during flooding incidents. (See picture below)

Such a system could reduce accidents and vehicle damage, improving road safety in the Carlow Municipal District."
